

# ANNUAL REPORT TO THE **MEMBERSHIP** 2006

## Letter from President



I am going to combine 2006 with 2007 this time. This has been an exciting year on many fronts. We began with knowledge that housecalls were increasing at a rate faster than office visits, growing membership, and lots of ideas. We ended 2006 and began 2007 with housecalls leveling out and a reduction in payment, yet dramatic evidence of new support at every level for increasing the physician's role (and

Meanwhile, there is the prospect of four new CME conferences on physician housecalls in the fall, planned in conjunction with HouseMDToday, a private CME reimbursement) in the field. company committed to the expansion of the very knowledge base we have worked so hard to create. Membership has actually grown despite the speed bump of work RVU decreases. Articles appear weekly in the major journals and papers extolling the virtue of housecalls. The Academy showed its influence by having a major Local Carrier Decision withdrawn. It is being rewritten with our strong influence so as not to threaten payment for housecall clinicians. The beginnings of a Class Action lawsuit is gaining momentum to provide respite to the near-universal Carrier misunderstanding of how to audit and pay for home visits. Most importantly, this spring we completed the working draft of our major new legislative

proposal, called the Independence at Home Act, which has been received with strong support by members of both the House and Senate. This legislation, which we hope to have introduced by the end of 2007 and passed next year, is an important answer to the coming Medicare insolvency. By awarding a share of global savings in both Part A and B Medicare for providing comprehensive care in the home for that group of patients consuming nearly half of the Medicare budget, home care clinicians can finally anticipate having the resources and incomes to coordinate, and control, all aspects of care where the patient wants to be. With this higher vision, we now lead the discussions with other professional societies, rather than try to hang onto coattails. It has been a great privilege to share expertise with like-minded clinicians in the past

many years. The sacrifices we make to prevail in what is, in fact, an entirely new delivery model of healthcare are extraordinary. To see the dramatic and immediate response of contributions over \$50,000 for the Fund for Home Care Medicine in less than two months when we called for help showed that Satchel Paige was right: "If you want to get something done,

## Membership, Programs, and Services

1. Membership Diversification: While the AAHCP's membership remains small (around 740 members), we are delighted with the growth in diversity of our membership, reflecting the diversity of interest in our field. Today, Nurse Practitioners, Registered Nurses, and Physician Assistants make up nearly 20 percent of the Academy's membership. Sixty-seven percent of our membership is made up of physicians, and the remaining members are employees of home care agencies, residents, and students.

#### 2. Building and Documenting Qualifications

a. The Home Care Credentialing Examination:

This self-study examination, taken over from the American Board of Internal Medicine, gives home care medical professionals (MDs, NPs, PAs, and others) the opportunity to gain a credential that will document their advanced qualification in this field. To date, more than 60 home care medical providers have passed the exam. The Academy has also developed a bibliography of articles relating to home care that serves as a study guide for the exam.

b. The Faculty Development Seminar: In the seminars, invited faculty who teach residents are given a program to acquaint them with options for teaching house calls and home care medicine to residents. The Residency Training Faculty Development Seminar Materials are available for those interested in hosting a seminar.

#### 3. Publications:

The most important publication produced this year was the updated *Medical Management of the Home Care Patient: Guidelines for Physicians*, written with the American Medical Association. Single copies are available on our website or can be ordered. Bulk copies can be ordered through the AMA.

4. Annual Scientific Meeting and Member

Recognition: Called "The Expanding Role of High Technology Medicine in the Home," the 2006 program included presentations on computerized impedance cardiography, application of the community acquired pneumonia guidelines in the home-based patient and the Personal Visiting Physician Delivery System model. Winner of the Eric Baron House Call Doctor of the Year Award was Dr. Elizabeth Glazier, and of the Poster of the Year Award, Dr. George Shannon. Dr. George Taler was given an Award for Special Achievement. The first full-day Practice

Management Session was held the day prior to the Annual Meeting.

- **5. Newsletter:** This year's bi-monthly editions have covered abstracts of the home care literature, and a variety of public policy, clinical and practice management topics. The Newsletter is available in the member's only section of the website.
- **6. Public Policy:** 2006 saw us begin the process of trying to assure more adequate payment as proposed and enacted declines were published. Activity is ongoing in 2007.
