Category	Definition
Manufacturer – Boats	Individuals whose primary business is building boats.
Manufacturer - Engines	Individuals whose primary business is building engines and propulsion systems.
Manufacturer Accessory	Individuals whose primary business is building accessories for boats eg. Accessory and equipment manufacturers, and raw material suppliers
Insurance / Survey	Individuals trained as surveyors and/or individuals whose primary employer is an insurance company.
Specialist Service	Individuals who are boat repair technicians, boat dealers, or other positions at a boat yard or service industry.
Specialist Misc.	Individuals employed as Lawyers, specialists and consultants, writers, naval architects and individuals who are employed by testing labs.

### **PROJECT TECHNICAL COMMITTEE PARTICIPATION**

Participation in project technical committees (PTC) is governed by the following rules for membership, voting and attendance.

- a) Members of the technical board and members of committees under it shall function independently as individuals and not as agents or representatives of organizations with which they are or may be associated or employed unless a committee member designates himself as such agent or representative.
- b) Must have educational or experience credentials that are beneficial to the PTC.
- c) An appointment to a PTC is an individual appointment not a corporate position.
- d) Must attend and actively participate in all PTC meetings and must complete and return all letter ballots.
- e) Failure to attend two consecutive meetings without prior notice and failure to return two consecutive ballots to ABYC headquarters on time will result in dismissal from committee or transfer to committee mailing list.
- f) Are you a member of ABYC? If not, we believe that it would be to your benefit to join so you can be kept abreast of the activities of related committees.
