Public Lands Update-Randy Rasmussen

Forest Trails Act

Taken leadership role in implementation of the National Forest System Trails Stewardship Act. Objectives include facilitating dialogue with the USFS and to demonstrate unity among the broader trails community. The agency must first identify 9-15 "priority areas" for enhanced trail maintenance opportunities. In refining criteria for the agency's selection of priority areas, BCHA reached out to, and included the input of, the following partners: TWS, AHS, International Mountain Bicycling Association, National Wilderness Stewardship Alliance, American Motorcyclist Association, and BlueRibbon Coalition. Criteria developed will be forward to the USFS WO.

Hike the Hill

Traveled to Washington DC to participate in the annual Hike the Hill lobbying week, sponsored by AHS and PNTS. Topics of mutual interest included Forest Trails Act implementation, LWCF and the Wildfire Disaster Funding Act.

Met with several key congressional offices and, importantly, with staff of each of the four Forest Trails Act sponsors, to thank them for their leadership and to provide updates on Act implementation. Explored opportunities for further actions to address the USFS trail maintenance backlog, including actions to enhance agency resources via its annual trails/recreation budget. Met with USFS Chief, Tom Tidwell, to receive his thanks to BCHA for its longstanding record of service in maintaining forest trails and for its efforts to raise awareness and to inspire action to address the USFS trail maintenance backlog. Thanked Chief Tidwell for his leadership is shaping a series of Trails Connect dialogues, completing a new saw policy, and for engaging the public in the soon-to-be-released *National Strategy for a Sustainable Trail System*. Met also with USFS WO representatives to discuss timeline and implementation of the Forest Trails Act and other opportunities for continuing our partnership.

Met with allies to refine a course of action should the "Human-Powered Uses in Wilderness Areas Act (aka, "bikes-in-wilderness" bill) be reintroduced in Congress.

Other

In concert with **BCH Nevada** and TWS, submitted joint letter to BLM Elko Field Office expressing our interest in shaping and participating in their trails- and recreation-related planning efforts for Lincoln County, NV. Suggested that BCHA and TWs might work jointly with the BLM in order to "promote hiker and horseback riding opportunities" as per our new (2016) three-way MOU. Coordinated with **BCH Alabama** and the USFS Region 8 Trails Program Manager in response to agency deliberations that could result in the elimination of existing bridges and the use of wagons in the Sipsey Wilderness.
