Colorado Regulatory Changes

The Colorado Department of Labor and Employment (CDLE), Division of Oil and Public Safety plans to propose changes to the current regulations for Amusement Rides and Devices. A link to the summary of proposed changes is posted on the CDLE web site here. If you would like to review the current regulations you can find a link here.

A hearing will be held at 1:30 p.m. on Thursday October 25, 2012 at the Colorado Department of Labor and Employment 633 17th St. Room 2A Denver, CO 80202 to discuss the proposed changes. CWA will have a representative at the hearing.

Massachusetts Public Hearing Notice

The Commonwealth of Massachusetts Department of Public Safety has released a notice of public hearing that will be held on November 28, 2012 at 10 a.m. at One Ashburton Place, Boston, MA concerning a <u>new law</u> that allows the Department to assess monetary fines for violations of certain statutes and regulations related to amusements as an alternative to initiating criminal proceedings. Climbing walls are currently regulated as amusements in Massachusetts. The Department has drafted new regulations, <u>520 CMR 1</u>, that establish issuance of these fines by Department personnel. The CWA will have a representative at the hearing.
