

## CLSA Attends ASOMEXCAN Meeting

**F**ourteen members of the CLSA in the United States attended the annual assembly of the *Asociación Mexicana de Canonistas*, July 19 to 23, 2004 at the *Centro Pastoral Juan Pablo II* in San Juan de los Lagos, Jalisco, Mexico. The Most Reverend Raymundo Peña of Brownsville, Texas, provide the keynote address on the impact of the clergy sexual abuse cases upon dioceses, bishops, priests, and laity. The Reverend Lawrence J. O'Keefe spoke in Spanish-English addressing a marriage case involving cultural elements affecting simulation allegations, and Monsignor Mark Bartchak provided a session in English with Spanish translation on distinctions, coordination and avoidance of conflict among the external forum, the internal forum, and the forum of conscience with a focus on seminary spiritual formation. Dr. Luis de Jesus Hernandez spoke to the delegates on matters of parish administration. Monsignor Doctor J.J. Garcia Failde, Dean of the Spanish Rota provided a series of lectures on procedural law to the 163 gathered delegates.

Many of the older Mexican canonists who attended the annual meeting spoke fondly of their association with the United States and memories at Montezuma Seminary outside of the city of Las Vegas, New Mexico, in the Archdiocese of Santa Fe. During a period of twentieth century troubles in Mexico, it was necessary to educate seminarians north of the border. In our informal discussions, there were many points of common interest for canonists in Mexico and the United States to pursue in the future.

At the business meeting, the members of ASOMEXCAN thanked the members of the Canon Law Society of America for their donation of *Codigo, Comunidad y*

*Ministerio* which the Society donated to their members in Mexico. There was also a request that the officers of ASOMEXCAN and the CLSA explore the possibility of a future joint meeting for the two societies. The dates for next year's meeting were set as July 11 to July 15, 2005 again at San Juan de los Lagos. # Summer Travel Schedule Leaves Little Time for Reflection

This summer seems to have gone by quickly. At least that's what the young people in my parish tell me as they prepare to return to school in just a couple of weeks! I certainly have kept busy this summer.

At the invitation of Msgr. Patrick Powers, President of the Canadian Canon Law Society, I attended a symposium in Toronto, Ontario, for bishops and canonists on clergy misconduct and related issues. A number of members of the CLSA were also in attendance. The program and presenters were quite good. It was certainly a worthwhile continuing education opportunity for me. It was also a great pleasure to renew acquaintances with members of the CCLS and to meet some of the Canadian bishops. Many of them expressed their appreciation for the CLSA *Revised Guide to the Implementation of the U.S. Bishops' Essential Norms for Diocesan/Eparchial Policies Dealing with Allegations of Sexual Abuse of Minors by Priests or Deacons*, which was included in the symposium materials.

During the week of July 19, I was in San Juan de los Lagos, Jalisco, Mexico, to participate in the annual meeting of the Asociación Mexicana de Canonistas

(ASOMEXCAN). I am grateful to Msgr. Jorge Luis Roque, President of ASOMEXCAN for the gracious hospitality. As a first-time visit to Mexico, I was delighted not only by the beautiful surroundings and weather in San Juan de los Lagos, but also with a number of cultural and religious experiences. It was also a first for me to hear mariachi music in person. Also, the beauty of the cathedral church (which is also a basilica in honor of Our Lady of San Juan de los Lagos) and the piety of the local people were impressive. We also had the pleasure of being invited for dinner at the residence of the Most Rev. Javier Navarro Rodríguez, Bishop of San Juan de Los Lagos. He presented us with a copy of a book which chronicles the martyrdom of several Catholics in that region of Mexico during the 20th century.

CLSA Past President Lawrence O'Keefe and I each made presentations at the ASOMEXCAN conference. Bishop Raymond Peña of Brownsville, Texas, was the keynote speaker. There is a great interest among the ASOMEXCAN members for further interaction with the CLSA. The idea of a future joint convention (similar to what we have done with the Canadians) with bilingual presentations was discussed. I offered to bring that to the CLSA BOG for consideration. They were pleased to know that the ASOMEXCAN President will be presenting a seminar at our convention in Pittsburgh. The several CLSA members from throughout the USA who attended the ASOMEXCAN meeting expressed their hope that our two organizations can have further interaction.

I was in Philadelphia August 2-5, for the Gregorian University Canon Law Colloquium. Bishop Velasio DePaolis from the Apostolic Signatura was the first presenter. Several professors from the faculty of canon law (including CLSA members James Conn, SJ, Robert

Geisinger, SJ, and Michael Hilbert, SJ) gave presentations on a variety of topics. Best wishes are extended to Michael Hilbert as he begins his new duties as dean of the faculty of canon law in September. The following week I attended the Oklahoma-Arkansas Provincial Workshop, which is the last of the regional meetings for this cycle. Ronny Jenkins from CUA was the presenter and he covered a number of topics in the areas of jurisprudence for marriage cases. I am grateful to Scott Marczuk and Royce Thomas for their hospitality.

# Pittsburgh Convention Update

As of the publication of the CLSA Newsletter, we are able to announce that the CLSA pre-Convention Workshops on penal procedures and select elements of jurisprudence for those engaged in Advocacy or Adjudication in Cases of Sexual Abuse of Minors by Priests and Deacons will be well attended. The adjudication section is completely booked and only a few places remain in the advocacy section. The workshops, facilitated by Monsignor Ronny Jenkins of The Catholic University of America and the Reverends Daniel A. Smilanic and Patrick R. Lagges of the Archdiocese of Chicago will consist common sessions and break out sessions during the

October 10-11, 2004 pre-convention.

On Monday, CLSA members and friends will join those pre-convention attendees as the sixty-sixth annual meeting, *VITA SACRAMENTORUM: WORSHIP AND SANCTIFICATION* gets underway at the Hilton Pittsburgh, Gateway Center. Those traveling by air may find that US Airways will offer a member discount on air travel between October 7-17th, 2004 using Gold File Number 39133034. A shuttle operates between the airport and the Hilton, and advance reservations are not required.

This year the Convention Planning Committee was able to respond to a long standing request of members. The Wednesday afternoon sessions from 2:30

to 4:00 P.M. were designated as “free time” in order for caucuses and committees to meet during the convention. Members of CLSA committees should contact their committee chair to determine whether or not their committee will meet during this time space.

Shortly before his death, Dr. Patrick S. Morris, Ph.D., of the Diocese of Raleigh, NC, contacted the Executive’s Office that he would not be able to make his presentation “Alcoholism and Marital Consent.” Preparation of the address was hampered over the past months by the aggressive advance and treatment for cancer. It was a great source of disappointment to Patrick that he would not be able to give this presentation. ▼

## IN MEMORIAM

The Executive Coordinator’s office learned on July 6, 2004 of the untimely death of the **Reverend Michael Lynch** of the Diocese of Galloway, Scotland. Father Lynch died in a house fire at his parish of St. Peter’s Ardrossan, Diocese of Galloway, Scotland. A judge on the Scottish Regional Marriage Tribunal since 1976, Michael joined the CLSA on December 2, 1982. He was a frequent visitor at the CLSA conventions as well as an active participant in the Canon Law Society of Great Britain & Ireland. Michael served the tribunal well in marriage and canonical ministry but always was proud to list himself as a “parish priest.”

The **Rev. Msgr. Anthony L. Capitani** passed away on April 23, 2004. A priest of the diocese of Trenton, New Jersey, Monsignor entered the CLSA in August of 1983. Prior to his canonical ministry, he served as a U.S. Army Chaplain from 1958 to 1978 and then as Deputy Catholic Welfare Bureau of the Diocese of Trenton. In 1981 he joined the Diocesan tribunal after receiving his JCL degree from The Catholic University of America in 1981. Over

the years he continued as a judge in the tribunal as late as June 11, 2003.

**Reverend David J. Byrne** of the Archdiocese of Chicago, Illinois, passed away June 13, 2004. A member of the CLSA since January of 2000, Father Byrne became an associate member of the society during his time in the chancery and tribunal. He earned his BA from John Carroll University in Cleveland, Ohio, (1964) and an M.A. at Indiana University in Bloomington, Indiana, in 1968 before earning his M. Div from St. Mary of the Lake in Chicago in 1978.

The Executive Coordinator’s Office learned in mid July from Father Vincent M. Lachendro, O.F.M. Cap. of the death of CLSA member **Father Charles Ermin Bantle, O.F.M. Cap.** who passed away June 27, 2003. Father Charlie (as his friends commonly called him) arrived in Okinawa in 1950 and served there until his death. At the time of his death, Father Bantle served as Pastor of Our Lady Health of the Sick in Asato, Okinawa, Japan. He served as vicar general, chancellor, judicial vicar and episcopal vicar for the U.S. Military Archdiocese.

Notification came in late July of the death of **Deacon Rudolph F. Lohmann**

of Schaumburg, Illinois. No further information is available. Deacon Lohmann joined the society in May of 2000 as a pastoral assistant at St. Matthew Church in Schaumburg and his involvement in the Diaconate Formation Program of the Archdiocese of Chicago.

The Tribunal of the Diocese of Raleigh announced “it is with profound sorrow that I tell you that **Dr. Patrick S. Morris Ph.D., JCL**, Director of the Raleigh Tribunal, formerly of the Tribunal of London, Ontario, has succumbed to cancer at 5:01pm, Friday, August 6, 2004, here in Raleigh, North Carolina. Funeral arrangements are incomplete at this time. There will be a memorial service here at the Cathedral in Raleigh where Pat was a member and a memorial service in Ontario with the interment of his ashes in the family cemetery there. Patrick was an alumnus of Saint Paul University, Ottawa; an outstanding canonist especially on his research on canon 1095 among many other works; a very dear friend to us who knew him. I ask you to please keep his happy repose in your prayers as well as his beloved wife Carolyn and daughters Erin and Andrea.” ▼



**PRE-PAYMENT:**

CLSA Publications requires prepayment by check or credit card at the time of purchase on all orders placed by individual persons. Make checks payable to the CLSA in USA currency only; the Society takes Visa and MasterCard credit cards only. All international orders must be prepaid either by check drawn on a USA bank or by one of these credit cards. No returns after thirty (30) days from date of shipping; all returns must be in saleable condition, accompanied by a packing list or invoice, with the purchaser paying postage charges. Additionally, bookstores (resellers) require advance authorization from the CLSA for all returns, which must be made within ninety (90) days of the original invoice date. A 15% restocking fee will be applied for returns of five or more copies of any one title.
