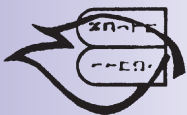

CLSA Scholarship Fund Needs Support

One of our CLSA members recently pointed out that one of the most significant changes from the 1917 *Code of Canon Law* to the 1983 code was the movement from concern for the institutions of the Church to a concern for individuals. It was a change initiated and advanced by teachings of papal encyclicals from Pope Leo XIII to our own Holy Father Pope John Paul II. In a world continuously torn by warfare and strife, the Church seeks to advance the rights and the responsibilities of the people of God.

The Canon Law Society of America can proudly look at the educational aspects of its mission to promote the study of canon law and its pastoral application to advance rights and responsibilities by rule of law as opposed to rule by person. As a respected professional society both here in the United States and throughout the world, the CLSA must lead the way in promoting new canonists in the Catholic Church. Our world is increasingly faced with discord and division, and our financial resources to support the education of canonists remains limited.

Established in 1985, the CLSA Scholarship Fund helps clergy, religious and laity pursue a licentiate degree in canon law at a university here in the United States, or Canada, or Europe. Funding for the CLSA Scholarship primarily comes from the members and friends of the society and a modest yearly donation from CLSA Publications. One will find in the *CLSA Proceedings* an accounting for revenues generated by the scholarship investment. The sluggish performance of the stock market and the rising costs of education suggest that membership donations to the scholarship fund are more important than ever. A contribution, no matter how larger or small, from a larger portion of our 1500 + membership speaks loudly to those who look to our society for leadership in canonical ministry. A one time contribution of \$10 dollars from each of our

members generates fifteen thousand dollars; and \$25 dollars would create over thirty-seven thousand dollars.

Each year the Board of Governors determines the total amount of funding available for the next funding year at its January board meeting. The value of the award is based upon a percentage of the scholarship fund as of December 31st. At the present time, the board is able to offer a partial scholarship of five to six thousand dollars.

The annual 2005 Advent appeal for the CLSA Scholarship Fund will begin the First Sunday of Advent. Please consider responding to the Scholarship Committee's request. For the first time, the Board of Governors authorized that members be afforded an opportunity to donate to the domestic or the new international scholarship fund. Some members may wish to donate to both funds or to split their contribution between the two. Both the domestic and the international scholarship funds are increasingly important as requests come in weekly for consideration. ▼

The Pittsburgh convention, whose theme was *Vita Sacramentorum: Worship and Sanctification*, was by all accounts a great success, due in no small part to the generous efforts of many people prior to and during the convention, especially Mrs.

We continue to hear high praise for the valuable assistance provided to participants in the Pre-convention workshop on "Penal Procedures & Selected Elements of Jurisprudence for Those Engaged in Advocacy/Adjudication in Cases of Sexual Abuse of Minors by Priests and Deacons." Canadian Canon Law Society Convention a Big Success

Participants of the three hundred and thirty-five member Canadian Canon Law Society gathered for their 39th Annual Convention at Charlottetown, Canada, October 18 — 21, 2004. The theme for this year's meeting on Prince Edward Island commemorated the 400th anniversary of the Church in Arcadia with reflections on the theme: **Canon Law and the Rights and Obligations of the Faithful**. The Reverend Kevin McKenna delivered the opening session, "The Rights of the Christian Faithful," and the Honorable Doctor Noël Kinsella provided the closing session on "Human Rights in Canadian Society." On Tuesday afternoon, Mr. Léon Thériault delivered a fact filled and interesting historical description of the

"The Acadian Church" in the Maritime provinces between 1750 and 1850.

Participants were able to attend a variety of seminars, many available in English and French. Father Roland Jacques, O.M.I., spoke of the "Historical View of the Rights/Obligations of the Christian Faithful in the Church;" Sister Marie-Paul Courturier, F.M.A. addressed the "Rights of Religious and Novices in a Context of Decreasing Numbers;" Msgr. Roch Pagé spoke of "From Pain to Hope — Today." Reverend John Barry spoke on "The Rights and Obligations of Dioceses," and Dr. Michael McGowan addressed "Canon Law and Human Rights." Reverend Michael Walsh guided participants through pastoral planning with his address: "Harmonization of Lay and Ordained Ministries in a Parish in response to 'Forward in Faith' Pastoral Planning for the Future in the Archdiocese of Halifax;

and M. L'abbé Jacques St-Michel spoke of "*La loi de l'accès à l'information et les droits des fidèles*." As in previous years, participants could attend panel discussions in English or French on "Financial Considerations in Marriage Nullity Cases and Other Questions."

The annual general business meeting took place on Wednesday. Elected to office were the following: Msgr. Roch Pagé as Francophone President; Lt/Col Rev. Jean Bourgeois as Francophone Vice-President; and Msg. Wayne Kirkpatrick as Anglophone Consultor.

In Memoriam

The Executive Coordinator's Office learned of the passing of the **Very Rev. John J. Hedderman** of the Diocese of Salt Lake City, Utah on October 4, 2004. Born in 1932, Father Hedderman received a B.A. degree from St. Patrick's College, Menlo Park, California in 1956 before being ordained in 1960. He received his JCL degree from The Catholic University of America, Washington, DC. Since 1963 he served his diocese in the Chancery and Tribunal.

Mr. Robert G. Wesselmann of Acworth, Georgia, a member of the CLSA since 1958 passed away on April 20th, 2004. Robert received an STL from St. Mary of the Lake, Mundelein, IL and a JCL from the Gregorian University in 1957. He served in a number of capacities in the Diocese of Belleville, IL, until resigning from active ministry in 1966. Within the CLSA,

Robert served as Chair of the Committee on Research and Discussion (1964-1965) and as a member of the Board of Governors (1965-1968). A champion for interracial justice, Robert kept as active in church activities as he could. He is survived by his wife Dorothy Wesselmann.

As most members and Catholics in the United States already know, **His Eminence James Cardinal Hickey**, Retired Archbishop of Washington passed away on Saturday, October 23rd, 2004. A long time member of the Canon Law Society of America, Cardinal Hickey graduated from Sacred Heart Seminary College in Detroit, Michigan, in 1942. He earned a licentiate in theology from The Catholic University of America in 1946 before beginning studies in Rome, Italy. He received his JCD from the Lateran University in 1950 and an STD from the Angelicum University in 1951. ▼

PRE-PAYMENT:

CLSA Publications requires prepayment by check or credit card at the time of purchase on all orders placed by individual persons. Make checks payable to the CLSA in USA currency only; the Society takes Visa and MasterCard credit cards only. All international orders must be prepaid either by check drawn on a USA bank or by one of these credit cards. No returns after thirty (30) days from date of shipping; all returns must be in saleable condition, accompanied by a packing list or invoice, with the purchaser paying postage charges. Additionally, bookstores (resellers) require advance authorization from the CLSA for all returns, which must be made within ninety (90) days of the original invoice date. A 15% restocking fee will be applied for returns of five or more copies of any one title. Replacement copies for those received in unsatisfactory condition must be requested and approved within seven (7) days of receipt by telephone at 301-362-8197 or fax 301-206-9789. HANDLING CHARGES:

All orders are prepaid and will include a packing slip. Handling charges at the distribution center are \$5.75 per order. For "rush orders" (24 hour turnaround) add an additional \$12.50 per order.

SHIPPING CHARGES:

CLSA Publications prefers all orders be shipped in the United States by United Parcel Service (UPS) to insure that

the shipment is trackable. Domestic customers may request alternative shipping, i.e. by "media mail" through the United States Postal Service with the following qualification. Orders shipped through the United States Postal Service are not traceable and CLSA Publications assumes no liability to replace lost items. Orders shipped by United Parcel Service are traceable and CLSA Publications will replace such lost items. International customers should consult with CLSA Publications as to the preferred international courier.

Domestic customers can calculate the cost of shipping using www.ups.com from a zip code origin: Annapolis Junction, MD 20701 or telephone CLSA Publications for calculation.

To estimate domestic shipping by United Parcel Service without a computer, calculate \$6.00 for the first volume and \$1.50 for each additional volume sent by UPS. 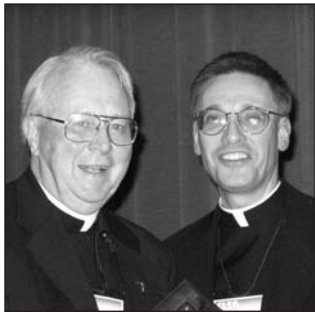

Saint Paul Faculty Offers Workshops

The Faculty of Canon Law of Saint Paul University announces two intensive workshops on tribunal practice and jurisprudence designed for canonists and advanced students of canon law to be offered May 16-20 and May 23-27, 2005. Registration is at 8:30 pm. Courses begin at 9 a.m.

Lecturers include, among others, Augustine Mendonça, Francis Morrissey, Roch Pagé, and Lynda Robitaille.

Applicants may enroll in either or both of the workshops. The morning sessions of Week 1 (May 16-20) will focus on the collection and evaluation of proofs and those involved in these processes: judges, auditors, advocates, promoter of justice and defender of the bond. Afternoon sessions are devoted to jurisprudence. A “mock court” will conclude the week.

The morning sessions of Week 2 (May 23-27) will focus on cases of incapacity, defects of knowledge, and defects of will. As in Week I, the afternoon sessions are devoted to jurisprudence, and a mock court will conclude the week.

Applicants should have a degree in canon law or equivalent studies, which normally should include introductory courses in Marriage Law, Procedural Law, Jurisprudence, and General Norms. The workshop fee is \$300 Canadian or \$250 US per week, payable on or before the first day.
