

## **SCMS DMCA Policy**

### **General:**

The Society for Cinema and Media Studies ("SCMS") website CMStudies.org ("CMStudies.org" or "site") is offered to you, the user ("User"), conditioned on acceptance of the terms, conditions, and notices contained therein ("Terms and Conditions") without modification. User access and use of this site constitutes acceptance of these terms and conditions. It should be noted when reading these Terms and Conditions that:

1. Access of the website from locations outside the United States are responsible for compliance with local laws where applicable
2. Failure or delay to enforce compliance with the Terms and Conditions does not constitute a waiver of the Terms and Conditions
3. Any provisions of the Terms and Conditions found to be void, unlawful or unenforceable are severable from the other provisions of the Terms and Conditions

### **Copyright Notice:**

The Digital Millennium Copyright Act of 1998 ("DMCA") provides recourse for copyright owners who believe that their rights under U.S. copyright law have been infringed on the Internet.   3. Identification of the material that is claimed to be infringing or to be the subject of infringing activity and that is to be removed or access to which is to be disabled, and information reasonably sufficient to permit us to locate the material;
  4. Information reasonably sufficient to permit us to contact the complaining party;
  5. A statement that the complaining party has a good-faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law;

6. A statement that the information in the notification is accurate, and under penalty of perjury, that the complaining party is authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.
