### Meet the 17 people who will help reshape Colorado's education policies

A who's who of Colorado's education community will help shape the state's new federally required education plan. The 17-member committee will be responsible for finding consensus while sifting through wide-ranging opinions about how Colorado should run its schools under the new Every Student Succeeds Act, which is supposed to give states more freedom to chart their own courses.

### Charter advocates hope favorable report leads to more equitable funding

They're also hopeful it spurs lawmakers to close the funding gap between charters and traditional public schools in the 2017 legislative session.

### Pueblo superintendent resigns abruptly as state sanctions loom

Pueblo City Schools, the largest school district in Colorado expected to face state sanctions next year for poor academic performance, is without a leader. Superintendent Constance Jones resigned Wednesday effective immediately after two years in the post, the school board announced during a brief emergency meeting.

Money spent to bring in more middle school and high school counselors helped keep almost 1,000 at-risk students in Colorado schools and send more of them to college, a new report shows.

The proposal would have allowed the state to keep revenue it collected over current limits set by the Taxpayer's Bill of Rights, or TABOR, for the next decade. Boulder Preparatory students gathered in a field outside the Gunbarrel high school on Wednesday to help launch a weather balloon. This webinar series will help schools establish a school response framework that shall consist of policies described in subsection (4) of the Act. By satisfying the requirements of subsection (4), a school shall be in compliance with the national incident management system, referred to in this subsection (4) as "NIMS", developed by the federal emergency management agency.
