Fellows are expected to participate in semi-monthly meetings conducted onsite at IEL; a Regional Leadership Forum; a national meeting for Fellows across all sites in Washington, DC; a state policy tour to Annapolis, MD; extended leadership sessions; and a leadership development assessment process. The **Regional Leadership Forum** brings Fellows together from several EPFP sites to spend a day at Gettysburg National Military Park and a day at the U.S. Army War College in Carlisle, PA, where instructors from the U.S. Army Department of Command, Leadership and Management share some of the strategic leadership concepts taught to military and government leaders at the War College. The **Washington Policy Seminar** increases Fellows' knowledge of national policy issues and processes and gives them a chance to explore the impact of national policy on their work. The **Annapolis Study Tour** provides Fellows with an opportunity to visit with legislators and key education policy officials and watch the legislative process in action. The **Executive Development Program** assesses the Fellows' leadership skills and potential and provides a thorough feedback mechanism for their professional growth.

The EPFP program tuition of **\$3,250** (includes \$500 non-refundable registration deposit due after notification of acceptance into program), plus program-related expenses (see Appendix A), are paid by the employing agency and/or the Fellow. Your signature ensures (1) your employee's release time for full participation in the program, (2) your agreement to serve as a sponsor to the Fellow throughout the program year, and (3) payment of the tuition fee by October 31, 2018. (Please note that if the applicant is bearing the financial responsibility for the program, he/she is responsible for paying the tuition fee before October 31, 2018).
