ADMINISTRATIVE ORDER S-2016-026 (Supersedes Administrative Order S-2015-036)

PRO BONO SERVICE

In 1990, the Florida Supreme Court held that "every lawyer of this state who is a member of The Florida Bar has an obligation to represent the poor when called upon by the courts and that each lawyer has agreed to that commitment when admitted to practice law in this state." In Re: Amendments to Rules Regulating The Florida Bar – 1-3.1(a) and Rules of Judicial Administration – 2.065 (Legal Aid), 573 So. 2d 800, 806 (Fla. 1990). Three years later, the Florida Supreme Court promulgated Rule 4-6.5(c) of the Rules Regulating The Florida Bar providing for the establishment of a pro bono committee in each judicial circuit. In Re: Amendments to Rules Regulating The Florida Bar – 1-3.1(a) and Rules of Judicial Administration – 2.065 (Legal Aid), 630 So. 2d 501 (Fla. 1993). Since 1993, the Thirteenth Judicial Circuit Pro Bono Committee has adopted and implemented its comprehensive pro bono plan with the assistance of the many bar committees, divisions, and sections and independent legal organizations.

By the power vested in the chief judge under article V, section 2(d), Florida Constitution; section 43.26, Florida Statutes; and Florida Rule of Judicial Administration 2.215(b)(2), it is therefore **ORDERED**:

1. Pro Bono Committee

The Thirteenth Judicial Circuit Pro Bono Committee ("Committee") will continue to provide oversight and direction of *pro bono* legal services for the indigent in Hillsborough County.

2. <u>Committee Leadership</u>

The Honorable Christopher C. Nash, Thirteenth Judicial Circuit Court Judge, is appointed Chair of the Committee. The Honorable Wesley D. Tibbals, Thirteenth Judicial Circuit Court Judge, is appointed Vice-Chair of the Committee.

3. Composition of Pro Bono Committee

The Committee comprises the following members:

- A. The Chief Judge of the Thirteenth Judicial Circuit or the chief judge's designee;
- B. Two representatives of the Hillsborough County Bar Association, one of whom should be a member of the board of directors and the

- other should be directly involved with the administration or organization of a Hillsborough County Bar Association pro bono event;
- C. One representative from each pro bono and legal assistance provider in the circuit whose organization is not otherwise represented on the Committee, including, but not limited to:

- F. One representative from each of the following local law schools:

- G. At least one public member; and
- H. At least one client-eligible member.

4. Ex Officio Members

The following persons will serve as ex officio and advisory members of the Committee: (a) any person currently appointed to The Florida Bar Standing Committee on Pro Bono Legal Service who practices in or resides in the Thirteenth Judicial Circuit; and (b) any past chair of the Committee who practices in or

resides in the Thirteenth Judicial Circuit. Ex officio members will be notified of and may attend each scheduled meeting or event of the Committee.

5. Administrator

The Committee will appoint or create a legally qualified entity (the "Administrator") to administer the Thirteenth Judicial Circuit Pro Bono Plan. The Committee has the authority to maintain or replace the Administrator. The Committee is responsible for assisting the Administrator in providing legal representation or assistance to the indigent in accordance with the rules adopted by the Florida Supreme Court. Since 1993, the Administrator has been and continues to be Bay Area Legal Services.

6. Annual Report

The Administrator will submit an annual report to the Committee which includes an assessment of attorney participation in the *pro bono* program during the preceding year and a plan for carrying out the *pro bono* program in the coming year.

7. <u>Committee Responsibilities</u>

In meeting its responsibilities under Rule 4-6.5(c)(2) of the Rules Regulating The Florida Bar, the Committee will meet periodically during the year to consider and review the Administrator's work, to oversee and allocate any funding, and to make recommendations on the community's needs, the possible resources available to meet those needs, and its long-term plan to fulfill the legal profession's obligation to its community. The Committee will submit an annual report to The Florida Bar Standing Committee on Pro Bono Legal Services.

8. Previous Administrative Order Superseded

This administrative order supersedes Administrative Order S-2015-036 (*Pro Bono Service*).

9. <u>Effective Date</u>

This administrative order is effective July 1, 2016.
