**AIU-ITAA Fashion Design Award - two awards, each for \$5,000USD**  
**AIU-ITAA Fashion Marketing Award - two awards, each for \$5,000USD**  
**Submission Deadline—April 1**

American InterContinental University (AIU) London provides awards to be applied towards tuition and housing costs (University coordinated housing only) during a regular academic term (10 week quarter) at the AIU London campus. The award does not apply to AIU programs conducted in other satellite locations. The student must be enrolled as an undergraduate in a fashion marketing or merchandising curriculum that has a current ITAA member on the faculty.

Each institution may sponsor only one applicant per year. The student must have completed a minimum of two years of a fashion marketing or merchandising program before application and must be a member of ITAA in the undergraduate student category. The student applicant must have at least one term to complete at the sponsoring institution after the study abroad experience. This award is applied to tuition and housing; (University coordinated housing only) it is not a reimbursement. This award may not be applied retroactively. Therefore, students who have already completed terms or who are currently attending an AIU Study Abroad Program are not eligible for a refund of tuition or fees. Recipients must use their awards within one year of notification. Applicants will be notified before August 1 of each year.

**Blanche Payne Scholarship for Textile and Apparel Design**  
**Two-Step Process**  
**Research Submission Deadline (4/1) or Design Submission Deadline (6/1)**  
**and**  
**Scholarship Application Deadline (8/1)**

Blanche Payne was a professor of Textiles and Clothing at the University of Washington during the first half of the 20th century. She was very supportive of textile and apparel design and is the author of the classic textbook, *History of Costume: From the Ancient Egyptians to the Twentieth Century*, originally published in 1965 by Harper & Row.

The Blanche Payne Scholarship for Textile & Apparel Design is a \$5,000 award for outstanding design scholarship and professional promise. For this award, ITAA recognizes that design includes apparel, costume, textile, and accessory design, functional and technical design; apparel product development; fashion illustration; and the scholarship of design theory and application. Undergraduate student applicant must have at least one design in the ITAA Design Exhibition (6/1 submission deadline) or a research paper in the Technical Design/Fashion Illustration track (4/1 submission deadline) at the ITAA Annual Meeting. All undergraduate submitters must be sponsored by an ITAA active, reserve, or emeritus member (see calls for papers for the ITAA Annual Conference) and must be members of ITAA in the undergraduate student category to be eligible for this award.

Undergraduate students accepted in either of these competitions must submit an electronic application to the Student Scholarship and Awards Committee by August 1 to be considered for the award. Scholarship selection criteria include: (1) Acceptance into at least one of the above exhibitions (design or research); (2) Statement of the design process with attention paid to the scholarship of design; (3) Potential for future contributions to and leadership in textiles and apparel profession; (4) Academically sound background and high level of scholarship; with a balance of textiles and apparel, and supporting disciplines; (5) Aptitude for advanced study; and (6) Enrollment at a degree granting institution.

#### **Apparel Magazine All-Star Award**

Apparel Magazine established the All-Star Award (formerly the Bobbin Award) to recognize a faculty member each year who has made outstanding contributions through teaching/curriculum, research, or service. Recipients must demonstrate exemplary and innovative contributions in teaching/curricular development, research, or service activities in the textile and apparel field; have a record of distinguished contributions to the textile/apparel field over a period of time; can show evidence of the impact of these contributions, either directly or indirectly, to the textile and apparel industry; and has fostered a positive image of the textile and apparel industry to students and has encouraged students to consider employment in the industry. It will not be necessary for the nominator to provide supportive materials. Nominees will be contacted to provide further support materials. Winner agrees to be interviewed for an "Educator of the Year" feature in Apparel Magazine.

#### **Fairchild Publications Textile and Apparel Faculty Grant**

The purpose of the Fairchild Publications Textile and Apparel Faculty Grant is to enhance the development of the textile and apparel field through support of ITAA members and their teaching and independent research activities. Emphasis for this award will be on the development of quality curricula and research that contribute either in depth or breadth to the field. One grant of \$1,500 will be given by Fairchild Publications. The award will be presented at the ITAA Annual Meeting. (Appropriate examples might include spending time with a manufacturing or retailing firm to gain expertise to develop or strengthen a course or a program, developing curriculum materials that could be shared with others in the field, going to summer workshops to gain new research capabilities, research projects that fit the description above, or a focused combination of activities.

#### **Sara Douglas Fellowship for International Study**

This fellowship is named in memory of Sara Douglas, professor at the University of Illinois. Dr. Douglas' research and teaching interests dealt with international trade in textile and apparel. Sara Douglas served ITAA in many capacities, including President in 2002/2003. Her colleagues, family, and friends have generously contributed to this award. This faculty fellowship is intended to support a project that will develop international linkages and collaborative cross-cultural research and/or teaching in textiles and apparel. For example, this award could support visiting scholars or travel to work on specific collaborative projects. This award may NOT be used to support travel to international meetings. Criteria for selection include:

1. Applicant must be an ITAA member. If program is submitting, the program must have at least one ITAA member as contact amongst its faculty;
2. Proposal is limited to two pages;
3. Application must include letter of administrative support from the institution(s) involved;
4. Results must be shared with the ITAA membership through paper, presentation, or ITAA Newsletter article; and
5. At least one recipient must be present to receive the award at the annual meeting.

#### **ITAA Visiting Scholar or Practitioner**

To further expand the charge of the ITAA International Relations Committee, "to promote linkages among all ITAA members and facilitate membership in ITAA beyond North America," the ITAA International Relations Committee requests proposals for *ITAA Visiting Scholar or ITAA Visiting Practitioner*. ITAA Visiting Scholar provides ITAA excellent opportunities to exchange scholarly activities with researchers and faculty members from emerging countries. ITAA Visiting Practitioner would help further bring fresh and new ideas to ITAA from outstanding practitioners from foreign industries and governments in the areas of technologies, trades, culture, history, and education that are critical in today's global society.

Both nominations and self-nominations will be accepted.

#### **Lois Dickey Fellowship for Continuing Doctoral Students**

This fellowship is named in honor of Lois Dickey, former professor at Ohio State University, early researcher and author of numerous articles on the social psychology of dress, and mentor to numerous students seeking advanced degree in the mid to late 20th century. Criteria for selection include: (1) Completion of the major portion of doctoral coursework; Award is conceived as financial encouragement for the dissertation research stage of doctoral work; (2) Acceptance of the dissertation proposal by the advisory committee; (3) Professional experience in and contribution to the textiles and apparel professional, including membership in ITAA; (4) Potential for future contributions to and leadership in the textiles and apparel professional; (5) Statement of professional goals; (6) Academically sound background and high level of scholarship with a balance of textiles and apparel and supporting disciplines; (7) Aptitude for advanced study and research; (8) Merit of the research problem; (9) Enrollment at the degree granting institution for the complete academic year of funding.

#### **Joan Laughlin Fellowship for Continuing Doctoral Students**

The endowment for this fellowship has been made possible by donations from Dr. Joan Laughlin, Professor Emeritus at the University of Nebraska. Dr. Laughlin's research on pesticide decontamination of textiles is used worldwide. Her award-winning research efforts were incorporated into the World Health Organization's analyses and EPA guidelines regarding protective clothing for pesticide use. She was a visionary leader for the Great Plains Interactive Distance Education Alliance (GPIDEA). She is an award-winning member and long-time supporter of ITAA. To apply for this award, the following criteria must be met: (1) Completion of the major portion of doctoral coursework; Award is conceived as financial encouragement for the dissertation research stage of doctoral work; (2) Acceptance of the dissertation proposal by the advisory committee; (3) Professional experience in and contribution to the textiles and apparel professional, including membership in ITAA; (4) Potential for future contributions to and leadership in the textiles and apparel professional; (5) Statement of professional goals; (6) Academically sound background and high level of scholarship with a balance of textiles and apparel and supporting disciplines; (7) Aptitude for advanced study and research; (8) Merit of the research problem; (9) Enrollment at the degree granting institution for the complete academic year of funding.

#### **Marjorie Joseph Fellowship for Beginning Doctoral Students**

This fellowship is named in honor of Marjorie Joseph, former professor at California State University-Northridge, author of numerous textile science articles and books, and the first editor of the *Clothing and Textiles Research Journal*. Criteria for selection includes: (1) Acceptance in a masters or doctoral program in textiles and apparel at an accredited institution; (2) ITAA graduate student member, professional experience in an contributions to the textiles and apparel profession including but not limited to involved and leadership in professional organizations; (3) state of professional goals; (4) academically sound background and high level of scholarship, with a balance of study in textiles and apparel and supporting disciplines; (5) potential for future contributions to and leadership in the textiles and apparel profession; and (6) potential for successful completion of an advanced degree.

#### **Oris Glisson Fellowship for Beginning Masters Students**

This fellowship is named in honor of Oris Glisson, former professor at Virginia Tech and Instrumental in the development of ITAA -Eastern Region in the mid 20th century. Criteria for selection include: (1) Acceptance in a masters program at an accredited institution; (2) ITAA graduate student member, professional experience in an contributions to the textiles and apparel professional including but not limited to involvement and leadership in professional organizations; (3) Statement of professional goals; (4) Academically sound background and high level of scholarship, with a balance of study in textiles and apparel and supporting disciplines; (5) potential for future contributions to and leadership in the textiles and apparel profession; and (6) potential for successful completion of an advanced degree.

#### **Sara Douglas Fellowship for Professional Promise – Masters and Doctoral Students**

This fellowship fund is named in honor of Sara Douglas, former professor at the University of Illinois. Dr. Douglas served many positions in ITAA, including President during 2002/2003. She cherished her role as a mentor to graduate students and young faculty. This award is intended to recognize graduate students who demonstrate outstanding potential and commitment to the field of textiles and apparel through support for travel to the ITAA annual meeting. Criteria for selection includes: (1) Nomination from an ITAA member or member emeritus; (2) Nominee must be registered in a masters or doctoral program in textiles and apparel at an accredited institution at time of nomination; (3) Nominee must be a student member of ITAA at time of nomination; (3) Awardee must be registered for and attend the ITAA annual meeting to receive the award.

### Research – Teaching – Technical Design

### Submission Deadline – April 1

### Research Presentations

ITAA scholars are invited to submit proposals to present original research papers at the ITAA Annual Conference. Appropriate submissions include research studies and scholarship from diverse theoretical positions. Research must be completed at time of submission and may not have been published or reported at a national or regional conference prior to the ITAA Annual Conference. Each paper must be presented by one of the authors in oral or poster format.

**Technical Design/Fashion Illustration/Textile Design:** Scholars are invited to submit proposals to present original research **posters** at the ITAA Annual Conference on Technical Design / Fashion Illustration / Textile Design. Appropriate submissions include design **research** from diverse positions, recognizing that design includes apparel, costume, textiles, accessories, functional and technical design, apparel product development, and fashion illustration. This call is for research only, and does not include the teaching of technical design or fashion illustration. Although the final poster can have a strong visual focus, the proposal should include a strong research focus. **Select the Technical Design track** for review and presentation.

Undergraduate students, who have posters accepted for the Technical Design Track, are then eligible to apply for the Blanche Payne Scholarship for Textile & Apparel Design. This is a \$5,000 award for outstanding design scholarship and professional promise. Criteria for selection include: (1) Undergraduate level standing; (2) Acceptance of at least one design entry in the ITAA Design Exhibition or a research poster proposal in the Technical Design/Fashion Illustration/Textile Design track at the ITAA Annual Meeting; (3) Statement of the design process with attention paid to the scholarship of design; (4) potential for future contributions to and leadership in textiles and apparel profession; (5) academically sound background and high level of scholarship; with a balance of textiles and apparel, and supporting disciplines; (6) aptitude for advanced study; and (7) enrollment at a degree granting institution. For more information go to Awards – Undergraduate Students.

**Research Peer Review Process:** Teaching and research papers will undergo double blind review. The following criteria will be used in evaluating papers: (1) Significance/usefulness of the research/scholarship; (2) Application of relevant theory or framework and pertinent literature; (3) Appropriateness of methods/exploration techniques; (4) Clarity of results/conclusions and implications; and (5) Clarity and organization of the writing.

### Teaching Presentations

ITAA scholars are invited to submit proposals to present papers on Creative Teaching, Curriculum Strategies, and Best Practices at the ITAA Annual Conference. Papers should report in narrative form and focus on: (1) Innovative teaching strategies; (2) The use of resources, media, and/or technology; (3) The process of curriculum development and evaluation as used in programs, courses and/or workshops; or (4) Best practices related to education programs. Papers may not have been published or reported at a national or regional conference prior to the ITAA Annual Conference. Each paper must be presented by one of the authors in oral or poster format.

**Teaching Peer Review Process:** Papers will undergo blind review. The following criteria will be used in evaluating papers: (1) New/creative/innovative strategy, approach, or practice that merits sharing with others; (2) Clear purpose/objective of strategy for identified audience; (3) Implementation of strategy/practice clearly delineated; (4) Description of effectiveness or success of the strategy or practice in fostering desired teaching/learning outcomes; and (5) Indication of plans for continuation, revision, or follow-up.

## Follow-Up

Authors will be notified electronically of the outcome of the review at the email address supplied by the submitter, and, if the paper is accepted, will be notified of the presentation format and pertinent information.

All papers presented at the annual conference will be included in the online *ITAA Proceedings*, and must be presented by one of the authors in oral or poster format. The presenting author must register for the conference by September 15, allowing the conference organizing committee adequate time to prepare the Conference Program.

## Papers of Distinction

Authors are encouraged to expand their papers into full articles that will be submitted for “Paper of Distinction” (*previously Track Best Paper*). The expanded paper will undergo a second double-blind review, and papers that are considered worthy of the title of “Paper of Distinction” will be recognized during the annual conference. Authors will then be encouraged to submit their expanded papers to the *Clothing and Textiles Research Journal* for publication.

To be considered for a Paper of Distinction Award, a **member must submit both the standard abstract and full paper by the April 1 submission deadline**. Abstracts will be reviewed first. Papers associated with accepted abstracts will move forward for review for the award.

**Authors should select from the following tracks for review and presentation (track code given in parentheses):**

- Aesthetics/Design/Product Development (ADP)**– including the creative process, factors of design, body scanning, product development for target markets, specification development, etc.
- Consumer Behavior (CB)** – including phenomena related to how consumers behave in the marketplace, shopping behavior, fashion movement, merchandise quality, consumption patterns and consumer practices.
- Culture (CUL)** – including cross-cultural comparisons, critical theory, ethnic studies, feminist theory, ethnographic studies, anthropological approach.
- Fashion Studies (FS)** – including theory of fashion, critical analysis of fashion through interdisciplinary thought, fashion as object, practice, etc.
- Historic (HIS)** – including artifact analysis, historic trends, archeological studies, cross-cultural comparisons, etc.
- International (INT)** – including trade analysis, economic theory, sourcing, global supply-chain, etc.
- Merchandising/Marketing/Retailing I. Management (MMGT)** – including issues related to satisfaction, stores, the retail process, etc.
- Merchandising/Marketing/Retailing II. Visual & Promotion (MVP)** – including issues related to E-commerce, advertising, branding, retail atmospherics, etc.
- Pedagogy (PED)** – the art and science of teaching including critical pedagogy, curriculum development, systematic analysis of teaching, etc.
- Popular Culture (POP)** – includes critical analysis of popular culture as it relates to the area of apparel/textiles including communication, ideas, perspectives, attitudes, images, media, etc.
- Professional Development & General (PDG)** – including future trends for the profession, curriculum issues, industry or inter-disciplinary linkages, professional development, etc.
- Social/Psychological Aspects (SPA)** – including appearance management, identity, group behavior, popular culture, body image, acculturation, gender and dress, etc.
- Sustainability/Social Responsibility (SSR)** – including issues focusing on environmental and social impact across all tracks.
- Textile & Apparel Industries (TAI)** – including sizing, manufacturing, socially responsible practices, production technology, etc.
- Textile/Apparel Science (TAS)** – including fiber science, functional dress, etc.
- Technical Design (TD)** – including design **research** from diverse positions, recognizing that design includes apparel, costume, textiles, accessories, functional and technical design, apparel product development, and fashion illustration

## Call for Proposals – ITAA Annual Conference

### Live and Mounted Design Exhibitions

### Submission Deadline – June 1

ITAA design scholars are invited to submit proposals to present original design work at the ITAA annual conference, during the Live and Mounted Design Exhibitions. Work must have been executed within the last 3 years and not previously shown at an ITAA Annual Conference. Work must be constructed by the designer(s), and must be completed at time of submission. Undergraduate student member submissions must have a faculty sponsor. The sponsor must be an ITAA active, reserve, or emeritus member, and one individual can sponsor up to six entries. It is the responsibility of the ITAA sponsor to screen the entries for quality, completeness, and accuracy and to be actively involved in the submission process. The sponsor will retrieve the design work at the conference if the student does not attend. All design work presented at the annual conference will be included in the online *ITAA Proceedings*. Up to 3 entries per designer or co-designer in any combination of categories may be submitted. A designer whose work is accepted, or the sponsor, **must attend the ITAA Annual Conference** and register for the conference by September 15, allowing the conference organizing committee adequate time to prepare the Conference Program.

The purpose of the ITAA Design Exhibition is to provide an arena for design work to be juried and shown as a form of scholarship. Graduate, undergraduate, and professional designs will be juried as separate categories. If more than one person contributes to a design, the creators will be designated as co-designers. If a faculty member is listed as a co-designer on a student entry, the entry will be reviewed at the “Professional Level”. The ITAA Design Exhibition includes a live gallery (static or runway) and a mounted exhibit.

### Categories for Review and Presentation

**Hawaiian Inspired Design - Special Category for 2012 Annual Conference Only** - Given the location of 2012 Annual Conference in Hawai'i, you are invited to celebrate the dress of Hawai'i with a Hawaiian or Hawaiian-inspired design competition. Judging will be by a panel of experts of Hawaiian dress and designers in Hawai'i. A winner of this category will receive a special certificate. Formats include:

**HILG** - Hawaiian Inspired Live Gallery

**HIME** - Hawaiian Inspired Mounted Exhibit

**Fiber Art** – Textile, apparel, or accessory items with emphasis on aesthetics and the use of materials, surface design techniques, and/or couture construction. This category can include apparel or non-wearable two- or three-dimensional designs. If a garment's stated priority is the surface design or weave structure, a commercial pattern or pattern from another source may be used. The pattern source must be identified. Formats include:

**FALG** – Fiber Art Live Gallery

**FAME** – Fiber Art Mounted Exhibit

**Target Market** – Garment constructed by the designer from an original pattern, with emphasis on materials, aesthetics, garment structure, and wearability. This category includes designs targeted toward a specific consumer, market group, or function. Formats include:

**TMLG** – Target Market Live Gallery

**TMME** – Target Market Mounted Exhibit

**Detailed instructions for online submission are posted separately on the ITAA Website.**

## Review Process

Each submission will be reviewed by a double-blind jury of your peers. The jury will view the Abstract and Images submission only and evaluate each entry based on: (1) Statement of purpose; (2) Implementation of purpose or process; (3) Aesthetics and visual impact; (4) Quality of technique and execution; and (5) Innovation of design. Acceptance or rejection for the ITAA Design Exhibition will be based on the jury's scores. The Proceedings file will be used for inclusion in *ITAA Proceedings* if your design is accepted.

An on-site review by a set of judges based on physical inspection and submitted abstract of each submission will determine award recipients. Entries may be disqualified at any level of the review process. Entries may be disqualified if a design is not delivered on time or by the carrier stipulated in the acceptance email **with the appropriate return postage**. Designs may also be disqualified if the submitter (or the submitter's sponsor) has not registered for conference on or before September 15. If the overall construction is judged to be poor during the on-site review, or if an apparel design is not easily donned or doffed, the entry may be disqualified. **The minimum openings in non-stretchable fabrics are: neckline 22"; waistline 28"; hipline 37"; and pant hem circumference 12". Knee-length or longer slim-fit skirts must have a vent, slit, or flare to allow adequate runway walking ease. Side-seam zippers in bodices must open completely at the arms eye to allow garments to fit over dress forms that do not compress. An image of the garment as it is worn is to be included with all accepted pieces. Detailed directions for donning and doffing non-standard garments also should be provided. Submitters are responsible for all customs fees and charges.**

## Follow Up

Entrants and their sponsors, if applicable, will be notified via email of the outcome of the jury review, and designers of accepted entries will be emailed guidelines for the delivery of their original images for the exhibition catalog and piece(s) to the annual meeting site where awards will be determined. Sponsors must be able to deliver and retrieve sponsored designs. Items selected for both the Mounted and Live Exhibit will need to be delivered or shipped to the exhibit site and items for the Mounted Exhibit must remain until the exhibit closes at the end of the conference.

**Non-Liability:** Reasonable care will be taken in handling and displaying accepted items. Neither ITAA nor the facility hosting the exhibit assumes responsibility for loss, liability, or damages incurred before, during or after the ITAA Design Exhibition.

- WHO:** Proposals are invited from current ITAA members. Individuals may submit no more than one proposal as Session Coordinator. No more than six presenters may be listed on a Special Topic. The Coordinator is responsible for assuring that all presenters register for the meeting. **Proposals are also invited from our resource vendors (current ITAA membership required). Vendor proposals must be generic and not product/service-specific.**
- WHAT:** Special Topic Sessions held during the annual meeting may include presentations, panels, small group discussions, or any other program which may be of interest to members. Special Topic Sessions occur within the regular meeting schedule and should address broad issues and encourage dialogue and audience participation.
- FORMAT:** Special Topic Sessions can be up to 75 minutes in length. Some sessions may be concurrent. Proposed sessions cannot exceed this time allotment. Proposed sessions should not require special facilities other than a meeting room. A LCD projector and screen will be provided to the Session Coordinator. Maximum number of attendees for each Special Topic Session will be based upon available facilities. There will be no reimbursement for expenses, fees, nor registration waivers provided for presenters. All benefits to outside speakers must be specified in this proposal.
- FILE:** **Each entry requires 1 file.** Name the file so you will recognize it; perhaps an abbreviation of the title of your entry. Be prepared to upload the file when the Online Submission Program asks for it. **Please save any Word document files with the ‘.doc’ extension and not the ‘.docx’ extension.**

**WHO:** Proposals are invited from current ITAA members. Coordinator must be a member. **Proposals are also invited from our resource vendors, and may include product/service specific content (current ITAA membership required).**

**WHAT:** Workshops held at the beginning and close of the annual conference; may include presentations, panels, group discussions, invited speakers, or any other program which may be of interest to members.

**FORMAT:** Workshops may be ½ to 1½ days. Any special facilities or equipment are the responsibility of the workshop coordinator. Number of attendees can be specified. At a minimum, workshops must be revenue-neutral to ITAA; you may require a registration fee to cover registration, audiovisual, meeting room, and other costs such as lunch (if provided) and internet access. The fee will be collected at time of registration for the annual meeting.

**FILES:** Each entry requires 1 file. Name the file so you will recognize it; perhaps an abbreviation of the title of your proposal. Be prepared to upload the file when the Online Submission Program asks for it. **Please save any Word document files with the ‘.doc’ extension and not the ‘.docx’ extension.**

**File 1.doc – Proposal:** should be no more than **2 single-spaced pages**. Names of presenters and moderators must be confirmed prior to submission. **Create a unique file for each proposal.** Each proposal should include:

- Name, address, email address, affiliation, and daytime phone number of coordinator
- Title of session
- Type of workshop (panel, speaker, etc.)
- Length of workshop
- Source of submission (individual, group, ITAA committee, etc.)
- General content of workshop and names of presenters
- Benefit of workshop to members
- Time frame of workshop organization (if call for participants is required)
- Minimum and/or maximum number of attendees

Detailed budget for the workshop. ITAA provides meeting room and possibility of borrowing an LCD projector only. The itemized budget must include all other costs, including a minimum service fee of \$10, and screen rental, other equipment, beverage break, and speaker fees if applicable. Submitters should contact the conference chair prior to preparing budgets to secure hotel costs for refreshments, request use of an LCD projector, and to gain approval for speaker fees etc.
