## **Air Leakage Rating Update**

As of January 1, 2015, only proper Air Leakage ratings are allowed for use on the NFRC temporary label per the [NFRC 700, Section 6.5.A.iii](#). The CPD has been modified to only display proper Air Leakage ratings as entered by your Inspection Agency (IA) ( $\leq 0.3$  for windows, skylights, and sliding glass doors;  $\leq 0.3$  or  $\leq 0.5$  for swinging doors and sidelites). If your window, swinging door, or sidelite is not displaying a value in the CPD Public Search, you will need to contact your IA to have your rating updated.
