May 2015

- **NFRC Certified Simulator Training Workshop - May 19-22, 2015**, near the Mall of America in Bloomington, MN.

This workshop is intended for those seeking certification for computer modeling in accordance with NFRC procedures for determining fenestration product U-factors, Solar Heat Gain Coefficients (SHGC), Visible Transmittance (VT), and Condensation Resistance, utilizing WINDOW and THERM computer programs.

- *The workshop requires knowledge of WINDOW and THERM.* The training is an in-depth review of these programs by solving interactive problems, as well as a review of the NFRC-accredited laboratory and certified simulator requirements. Training materials will be provided on a USB Drive on the workshop date.

PCP Participant Information

1. CA is the New Form of Authorization

- Starting November 2014 you may have noticed your Inspection Agency sending you a new format of authorization for certification of your new, revised, addenda product lines. This is the new official form called a "Certificate of Authorization." This provides pertinent information about your product line, the range of options authorized for labeling, and ratings approved for labeling. Participants can export detailed product line data using the Product Line Export feature, download the instructions in the CPD Participant manual [HERE](#).

2. New Submittal Form and Link
