April 2016

June 2016

- June 7-10, 2016 -- Certified Simulator Workshop. This workshop is for those seeking certification for computer modeling in accordance with NFRC procedures for determining fenestration product U-factors, Solar Heat Gain Coefficients (SHGC), Visible Transmittance (VT), and Condensation Resistance, utilizing WINDOW and THERM computer programs. Simulation of fenestration products with shading systems (complex glazings) is included in the training.

This workshop requires knowledge of WINDOW and THERM but you do not have to be proficient. The training is an in-depth review of these programs by solving interactive problems, as well as a review of the NFRC accredited laboratory and certified simulator requirements. Training materials will be provided on a USB Drive on the workshop date.
