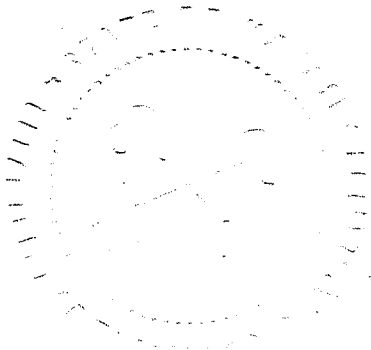

WHEREAS, said Active Members wish to form a Council of the Painting and Decorating Contractors of America (hereinafter PDCA); and



















WHEREAS, the undersigned tender this Application with the understanding that they will abide by the Bylaws of the PDCA; and
