

Renaissance Quarterly Author's Quick Guide to Image Permissions

The University of Chicago Press (UCP), the publisher of *Renaissance Quarterly* (RQ), requires that any necessary permissions be submitted at the time that articles enter production. Your RQ copyeditor will request that you submit permissions at the time that your article is accepted for publication. The following is a quick guide to obtaining the permissions you need. Requirements

Minimum requirements:

- non-exclusive world distribution rights in English
- right to publish in both the print and electronic editions
- right to deposit in electronic archives

Preferred rights, in addition to the minimum rights:

- non-exclusive world distribution rights in all languages, formats, and media
- right to reproduce in all reprints, editions, and derivatives, whether print or electronic

We cannot accept permission grants that:

- restrict use to a specific period of time
- require payment of renewal fees
- place restrictions on access to the material, especially in the electronic edition

Copyright and Public Domain

Permissions are required to reproduce copyrighted work. If you think that copyright may apply, please see the [University of Chicago Press Author's Permissions Guidelines](#). Under current US law, copyright lasts for the life of the author plus seventy years. Once copyright has expired, the work enters the public domain and no permission is required for its use. Therefore, most works reproduced in RQ are in the public domain, but you may still need permission from the library, archive, museum, or repository that controls access to the image, or from the photographer of the image.

Permissions

Use permission

You may require permission from the artwork's owner to access the work. Museums, archives, and other owners of artwork often place restrictions upon access to or use of the objects in their collection, in order to protect the works and to ensure that published images meet their quality standards. It is important to underscore this distinction between an access or use permission and a copyright permission.

In most cases you will need to work with the museums, gallery, or archive in which the work is housed. Sometimes they will be willing to waive or reduce their fees and other conditions for scholarly use, particularly if approached in a diplomatic way and if efforts are made to minimize any commercial impact the use may have on the work.

Photography permission

You may require permission to use the image (photograph) of the artwork. Typically, the photographer or the photographer's employer holds the copyright to the image. You will not need to obtain permission if you are the photographer; if you and the photographer agree to treat the photograph as a work made for hire (or the photographer agrees to transfer the copyright to you); or if the photograph lacks sufficient originality to be considered copyrightable. The latter instance occurs only in certain very limited cases—photographs of three-dimensional objects are copyrightable, but a photographic reproduction of a two-dimensional artwork is not. Please keep in mind that nonprofessional photographs of art objects are generally not publication quality.

Sources

Two sources for acquiring permissions for artwork are Bridgeman Images and Art Resource, which charge a fee that is based on your use requirements. We recommend that you request the following from Art Resource: “one-time, non-exclusive Worldwide English language rights for one print edition only (less than 3,000) and archived and available on microfilm, electronic databases or online services such as JSTOR or similar entries.”

Some sources will place restrictions on how an image can be used. It is your responsibility to make sure any restrictions are not in conflict with the requirements above, and that any credit lines stipulated in permission grants are included in your captions. Please read each permission grant carefully, keeping in mind that permission is required to reproduce works in both the print and electronic editions of the journal. As long as your permission request asks for permission to publish in both the print and electronic editions, we consider the permission grant to allow electronic publication implicitly, unless it is explicitly forbidden. The *RQ* editorial office can help you answer questions about how the material will be reproduced in both the print and electronic editions.

Wikimedia Commons is a media file repository that makes public-domain images available for free. Wikimedia does not own the content on its site, but makes it freely available to be reused, subject to certain licenses. The license conditions of each image can be found on the image's description page. Please check licenses carefully. Images with Creative Commons licenses that include “NC” (no commercial use) and “ND” (no derivatives, which means no alterations, including cropping) should not be used. To use Wikimedia Commons works, please make sure that the image is of publication quality (300 dpi is our minimum standard). Captions for Wikimedia Commons works should read: “Artwork in the public domain. Image courtesy of Wikimedia Commons” plus any specific language required by the license.
