### What is the Competition Act and why do I need to know about it?

The Competition Act applies to every business in Canada, big and small. It prohibits price fixing, bid rigging, and other conspiracies. It provides remedies for conduct that can lessen competition, such as abuse of dominance, refusals to deal, and mergers. It also enforces truth in advertising by businesses.

The Act contains serious penalties, including imprisonment for up to 14 years, and \$25 million fines. The Competition Bureau has enforced the Act against some of Canada's largest – and smallest – businesses.
