Bring your questions on any of the following professional issues, or others, but no substantive law questions please!

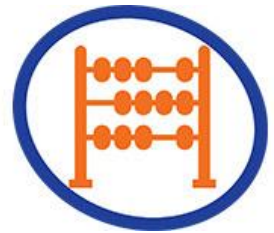
