- 3. TLA Whistleblower Protection Policy
- 4. TLA Apparent Authority Policy
- 5. TLA Record Retention Policy

2. Membership Committee discussion about Institutional Memberships:

The committee is working on possibly changing the incentives to increase the number of institutional members from the current seven that have renewed for the year. The board discussed the benefits of institutional memberships versus the cost of the investment as well as the impact upon TLA individual memberships. A survey is being created to seek input from TLA membership as well as possible institutional members.

3. Conference update:

Conference registration went live during the meeting.

The conference program is almost ready to go and information will go up in 7-10 days after the board meeting after the graphic artist has completed their work.

President Kinnersley and President-Elect Jennings reported that Corinne Hill has stepped down as cochair, and the new co-chair is Kathy Farley. Kathy will remain on as co-chair for 2015 conference in Memphis.

New Business:

1. TLA Library Leadership Roundtable

President Elect Susan Jennings presented Bylaws for a proposed TLA Library Leadership Roundtable.

Susan Jennings motioned as an individual member to send the proposed bylaws for the TLA Library Leadership Roundtable to the Bylaws Committee for approval. Seconded by Kevin Reynolds

Discussion

Wendy Cornelisen asked if language could be included about the Roundtable working with other groups such as the PLLMI. President Kinnersley agreed and stated that wording could be suggested by Bylaws Committee that the Roundtable would work with appropriate leadership and management organizations throughout the state.

The motion was approved unanimously.

2. Legislation:

Ruth asked Cara to discuss the Senate Joint Resolution 545 that seeks to create a task force to look at the obscenity statute in regards to library materials. This resolution as originally presented does not

include a library representative. TLA sent a letter to the sponsor, Senator McNally, expressing support of the task force and requesting library representation. McNally is glad to have the support of TLA. Ruth has asked Cara Huwieler, Chair of the Legislation Committee, to be the TLA representative.

Jason Vance, Legislative Monitor, reminded everyone about his document tracking legislation that can be found on the TLA website's Legislative Activities section under Committee Resources.

Announcements:

President Kinnersley related that ACRL has withdrawn their 2017 conference from Nashville due to the cost of hotel rooms.

President Kinnersley asked all committees, sections, and round tables to review the TLA strategic plan and how it relates to their group's work for the organization. The goal is to keep the strategic plan a working document that reflects the activities of the association.

TLA will migrate to a new website during May and June. During this time there will be no publications or other additions to the site. Publication dates will be adjusted accordingly.

There is no board meeting on Wednesday night before the conference, next meeting will be at the end of the board retreat May 30 and 31 at Montgomery Bell State Park, there will be paper registration for the retreat due to website migration.
