As my year winds down, I want to remind everyone that these next several months are a key to advancing our economic development goals and truly getting Wisconsin Back in the Game.

The special session in January will definitely incorporate parts of the Be Bold Wisconsin recommendations. In my view, it is now time for WEDA to go beyond the main

recommendation of restructuring Commerce and move to the funding and innovation recommendations that are needed to provide Wisconsin the flexibility to grow both our traditional and innovation-based economies.

A key message that I took away from the fall conference is that an innovation economy is based on strategic long-term investments and taking advantage of new opportunities, which requires long-term investments similar to those of a managed venture capital fund. The proposed Wisconsin Pioneers, with a funding model similar to the successful Kansas model operated by the Kansas Bioscience Authority, would be an important advancement in Wisconsin. This funding model seems to be more politically acceptable in the state's current economic situation, since it is pay as you go rather than adding debt through using bonding capacity. On a personal note, I want to thank Secretary Aaron Olver and his staff for their leadership during his time with Commerce. Several new financial tools were developed that long-term will enhance the performance of the state. While WEDA didn't see the Governor at our annual conferences, Commerce leadership did invite WEDA to the table to help structure several of these programs. The willingness of staff to collaborate in revising and developing new programs was greatly appreciated and a true

Legislative Update

Governor-Elect Scott Walker has announced that he will call the new Wisconsin Legislature into Special Session on January 3, 2011 to address economic development, job creation and Wisconsin's business climate. The Governor-Elect had vowed during the campaign to take quick action-before the start of the regular session--to help jump-start the state's economy. His announcement of the Special Session is a carry-through on that promise.

Representatives of WEDA and the Hamilton Consulting Group have been meeting with the Governor-Elect's Transition Team promoting important economic development initiatives including certain provisions from the recently concluded *Be Bold Wisconsin* study of which Scott Walker spoke favorably during the campaign.

It is important to understand at this point that no specifics have been released regarding what provisions will be included in the Special Session package. The Governor-Elect has clearly signaled that business climate, including improving our litigation atmosphere, is a high priority along with a sharper state focus on economic development initiatives and programs.

Please watch for WEDA Legislative Alerts and Calls-To-Action as elements of the Special Session are released.

WEDA leadership, the Legislative Committee and Hamilton Consulting also continue to fine-tune WEDA's legislative agenda beyond items to be included in the Special Session. While the results of the November election are old news, the new Governor and a new Legislature offer an opportunity for bold, progressive initiatives for the betterment of our state's economy and our business climate. - Start-up and companies with high-growth potential based in Wisconsin have attracted more angel and venture capital in the first nine months of 2010 than the totals of 2008 and 2009, according to a new report released by the Wisconsin Angel Network. The "2010 Wisconsin Portfolio" tracks early state investment.
- The Cultural Alliance of Greater Milwaukee recently announced initial findings about Southeastern Wisconsin's creative industries. According to the findings, there are 67,000 people employed in the creative sector in the southeastern Wisconsin region making up more than \$2 billion in wages. The study also indicated that nearly 46 percent of the creative professionals in the region are involved in the design industry. A full report of their findings will be available by the end of 2010.
