



Policy / Agreement for Use of ACCT Logo

The Association for Challenge Course Technology (ACCT) restricts the use of the member logo as stated in the following policy:

The Association's logo is a trademark and the property of ACCT. However, ACCT may grant a license to use the ACCT member logo to its Professional Vendor Members (PVM) and Business To Client Members in good standing upon approval. Only Professional Vendor Members or Business to Client Members who have maintained their paid membership in the Association will be authorized use of the ACCT member logo. Professional Vendor Members and Business to Client Members will not be authorized to use any other logo or trademark that is the property of ACCT.

Professional Vendor Members and Business to Client Members in good standing may be authorized to use the ACCT member logo for the purpose of identifying their membership in ACCT. The ACCT member logo may not be used in any manner to imply that a member is in any way an agent of ACCT or that ACCT in any way warrants, approves, or endorses any product or service provided by the member. Professional Vendor Member's and Business to Client Members may be allowed to use the member logo on business cards, letterhead, websites, and brochures with written successful approval of the ACCT Logo Usage application. The ACCT logo may not be used by member organizations on commercial products, which include hats, tee shirts, coffee mugs, or other similar products.

All other levels of ACCT Membership are prohibited from using the ACCT member logo or from allowing their employer to use the ACCT member logo. Anyone who uses the ACCT member logo without written permission from ACCT will be in violation of this policy and subject to legal action.

If permission is granted to use the member logo, the ACCT member logo should be printed using the ACCT member logo received from ACCT and not a newly rendered logo. The logo can be used in black and white or grayscale. The right to use the ACCT member logo shall terminate and be revoked upon the authorized member's failure to remain in good standing, a change in membership level, in the event of misuse by the member as determined by ACCT, or any other breach of this Policy for Use. Upon such termination and/or revocation, the unauthorized member will remove the ACCT member logo from all materials, products, and services, regardless of whether such materials, products, and services are preprinted or preexisting at that time.

Legal action can be taken against anyone who uses the ACCT member logo in violation of the above policy.
