

TRIAL TECH: TRIAL TECHNIQUE TRAINING WORKSHOP

Trial Tech: Trial Technique Training Workshop will feature instruction, live demonstration, and guidance by a panel of distinguished family law attorneys, bench officers, and experts. Offering family law practitioners the unique opportunity to participate in hands-on advocacy training, the series will be presented over eight modules (four in Orange County and four in Los Angeles). A single fact pattern will follow the trial process from Opening Statement through Closing Argument with Orange County modules focusing on property issues and Los Angeles modules focusing on support.

Each module will include:

- 1. Panel Demonstration.** Panelists will provide a live demonstration of the featured trial technique;
- 2. Panel Instruction.** Panelists will critique and explain the Panel Demo and discuss tips and practice pointers;
- 3. Attendee Presentation.** Attendees will have the opportunity to demonstrate the featured technique before the Panel;
- 4. Panel Critique.** The Panel will act as judicial officers and provide feedback and critique for each Attendee presentation; and
- 5. Trial Technology Training.** A brief look into how to use technology to improve and enhance courtroom presentation.
