The Summer Program for Women in Philosophy addresses the gender imbalance within our discipline by providing a summer enrichment program for female philosophy majors who are interested in graduate study. My UCSD colleague Rick Grush established the program in 2014 and stepped down after the completion of the 2015 program. At that point, I became the SPWP Director. This year (2016-17), we had an Executive Committee consisting of myself, my colleague Clinton Tolley, and our graduate student Kathleen Connelly. I am the primary director, Kathleen is the assistant director, and Clinton is a consulting director. As director, I work on fund-raising and grant application, program design, faculty recruitment, policy decisions, admissions, and supervision of the 2017 program itself. As a paid assistant director, Kathleen works on all these issues except the fund-raising/grant application tasks, and she attends to all of the logistics in preparation for and running of the 2017 program. Kathleen and I collaborate on all key decisions. Clinton offers policy advice and technical support and participates in admissions decisions. The success of this year's SPWP would be impossible without Kathleen's invaluable contributions.

In addition to the Executive Committee, we created an Advisory Committee, consisting of the Executive Committee and interested UCSD faculty and graduate students, some of whom participate in admissions and workshops and social events associated with the 2017 program.

Though the principal diversity contribution of the SPWP is to program participants and their academic development, the participation of UCSD faculty and graduate students in various aspects of the program produces a secondary diversity contribution, changing the attitudes toward diversity within our own the department and in the graduate students we train.

For 2017-18, Clinton and I will continue with our roles on the Executive Committee. Kathleen will be succeeded by another graduate student, Rosalind Chaplin, who participated in other SPWP roles in 2016 and 2017.

In addition to these leadership positions in SPWP, we have the support of our current Departmental Chair Jonathan Cohen and our Dean Cristina Della Coletta.

The SPWP has been a success and provides a model for how to address diversity problems within our discipline. As I say in our grant application, the continued operation of SPWP depends on extramural fund-raising and grants. In this connection, it is very significant that the UCSD Executive

Vice Chancellor has promised to match extramural contributions up to \$100K, which, together with modest intramural support, would guarantee our continued operation for several years. We have already secured one significant donation from a San Diego family and several smaller donations from UCSD Philosophy faculty, which the EVC will match. An APA grant of \$20K (or \$10K) would generate matching support, *doubling* its impact, amounting to a donation of \$40K (or \$20K)!
