She is an active member of Association of Women's Health, Obstetric and Neonatal Nurses (AWHONN) and has over 20 years of experience in obstetrics with a focus in the clinical areas of Labor and Delivery, Postpartum, High Risk Antepartum, Normal Newborn, and Women's Health. Trained as a certified nurse midwife, Cheryl is regularly invited to present on a host of clinical topics related to the care of women and newborns. As the CNS, Cheryl provides education, program development and planning, and coordination of safe care for high risk and low risk pregnant patients. Cheryl is currently the Michigan AWHONN Section Legislative Coordinator; sits on the AWHONN Public Policy Committee; and is an AWHONN Intermediate and Advanced Fetal Monitoring Instructor and a Designated Instructor for the Intermediate Fetal Monitoring Course. As a complement to clinical practice, she also actively promotes healthcare equity and the awareness of disparities with her involvement in policy and clinical strategies at the national, state, and local levels addressing preterm birth, infant mortality, and the reduction of maternal morbidity/mortality.
