## **NOMINATION GUIDELINES** (Please review before submitting nomination)

1. Nominations may be made by any CLC dues-paying member in good standing. A nomination form and supporting biography/documentation outlining how the nominee meets the criteria must be submitted to the Wall of Fame Selection Committee by the established deadline.
2. Late or incomplete nominations will not be considered.
3. No individual may nominate his or herself.
4. No one from the current Wall of Fame Selection Committee may be a nominee.
5. A nominee may be deceased, but this is not a requirement; however, deceased nominees must have passed away at least one year prior to induction into the Wall of Fame. Like political nature not being desired criteria, this helps eliminate emotional criteria.
6. Qualified nominees from the previous induction will be automatically considered by the committee along with the new nominees. If a nominee is not selected within a period of five years, he/she is automatically removed from the list of active nominees. A second nomination shall remain active for a period of three years, after which it will be placed on a permanent inactive status or in the inactive file.
7. The nominee must have significantly contributed to the CLC at the National level in both leadership and its heritage as well as having served in several capacities/different functional areas for 20 years or more. They may still be actively involved in the running of the Club.
8. Must be of upstanding character and integrity.
9. Must be/have been a CLC member in good standing. Any exception such as for General Motors or Cadillac executives or designers must be approved by the CLC board of directors.
10. While it should go without saying, to be clear, nominations from all genders and ethnicities will be given the same consideration. Selection shall be based on merit only and never of a political nature.

Please attach a 1½- to two-page single-spaced document stating the reasons/explanation of contributions supporting your nomination. (Review the list of Nomination Guidelines to ensure the candidate meets all qualifications.)
