SOCIETY ANNOUNCES MOBILE SUPPLEMENT TO 2017 CONVENTION

In an increasingly digital age, the Canon Law Society of America endeavors to connect with members and Convention attendees in new, meaningful, and accessible ways. In anticipation of the the 79th Annual Convention in Indianapolis, Indiana, the Board of Governors has

funded a new Guidebook application that conveniently houses all relevant data for Pre-Convention and General Convention attendees in one location. Get the app on your mobile device now, by scanning the QR code, or following the steps below:



1. Visit <http://guidebook.com/g/clsaconvention2017> on your mobile device.
2. Tap the “download” button to get the free app.
3. Open Guidebook and look for the guide: CLSA Convention 2017.

Begin to explore the schedule, information about presenters and candidates, directions and maps, and more!

- Build your own personal schedule by selecting seminars and functions you wish to attend.
- Create optional reminders for important events, whether Society-sponsored or individually organized with colleagues.
- Map out your day by noting function space and meeting room assignments ahead of time.

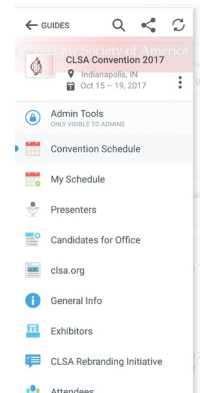
- Review the Candidate biographies prior to the Candidate Forum and the 79th Annual Business Meeting.
- Check the daily or weekly forecast before arriving in Indianapolis and/or leaving your hotel room.
- Receive push notifications on-site in Indianapolis, pending any changes to the program or content (e.g., new resolutions proposed at the Open Hearing, revised handouts from speakers, etc.).
- Evaluate major addresses and seminars in real-time, while the experience is still fresh.

The CLSA Convention Guidebook is in its early stages of creation and will be updated as we approach mid-October, to include all available seminar handouts, finalized meeting spaces, housekeeping announcements, a list of Convention attendees, and other pertinent resources.

RESOLUTION PROPOSALS

♦ 79th Annual Business Meeting of the Canon Law Society of America ♦

Wednesday, October 18, 2017

2017 RESOLUTION PROPOSALS (1 OF 1)

PROPOSED BY: Board of Governors

STATEMENT OF RATIONALE:

WHEREAS, staffing transition necessitates a reconsideration of duties and responsibilities assigned to administrative personnel;

AND WHEREAS, the Board of Governors maintains a supervisory and instructive role in the administration of Society business;

AND WHEREAS, the Board of Governors upholds the history of and canonical qualifications for the position of Executive Coordinator, while recognizing a separate and growing need for a position devoted exclusively to administration;

AND WHEREAS, the Board of Governors voted to restructure the Office of the Executive Coordinator at its April 2017 meeting, and subsequently publicized Position Descriptions for a part-time Executive Coordinator and full-time General Secretary;

AND WHEREAS, proper implementation of this restructuring requires minor amendments to the CLSA Constitution and Bylaws;

BE IT RESOLVED THAT Article VIII of the Constitution be amended with the following text:

1. Reporting to the Board of Governors and supervised by the President, two collaborative positions serve the Office: the Executive Coordinator, who is a degreed canonist, and the General Secretary, who is qualified in organizational management.
2. Financial provisions for the operation of the office shall be the responsibility of the Board of Governors in the annual budget.

BE IT FURTHER RESOLVED THAT all references to an Executive Coordinator appearing in the Constitution and the Bylaws shall be changed to refer to the Executive Coordinator and the General Secretary, *mutatis mutandis*. All references to the Office of the Executive Coordinator shall be changed to refer to the Administrative Office.

BE IT FURTHER RESOLVED THAT Article 16 of the Bylaws be amended with the following text: The General Secretary is the authorized agent for the Canon Law Society

of America in all matters, but especially pertaining to those areas denoted in the Position Description, for which such agency is required, unless the Board of Governors or President of the Society shall determine otherwise in particular cases. The Executive Coordinator is also an authorized agent for the Canon Law Society of America in all matters, but especially pertaining to those areas denoted in the Position Description, for which such agency is required, unless the Board of Governors or President of the Society shall determine otherwise in particular cases.

- a. The General Secretary shall maintain the Administrative Office.
- b. The duties of the General Secretary and the Executive Coordinator shall be defined in their respective Position Descriptions as approved by the Board of Governors.

IMPLEMENTATION BY MEANS OF: Modification to the existing language of the Constitution and Bylaws.

ANTICIPATED COST: \$0

HISTORICAL NOTE: All proposed resolutions are subject to review by the Resolutions Committee. Clarifications, modifications, and amendments may also be made to the resolution by CLSA members, with the approval of the author(s), at the Resolutions Hearing and the Annual Business Meeting.

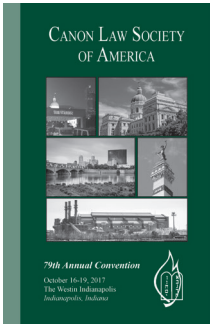

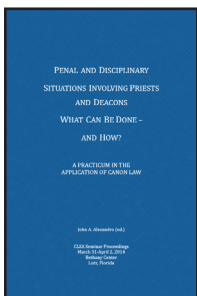

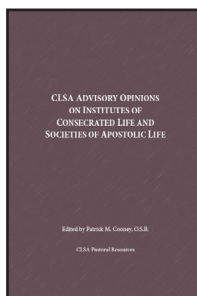
