Cobb Temporary Protective Order Project Coordinator

The Atlanta Legal Aid Society, Inc. (Legal Aid) seeks a full time paralegal to work for its Cobb Temporary Protective Order (TPO) Project, a specialty unit, in its Cobb County office. The Cobb TPO Project is housed within Legal Aid's Cobb office in downtown Marietta, within walking distance to the courthouse. The staff is comprised of a managing attorney, 5 full time attorneys, a pro bono director, two part-time attorneys, and four support staff. The Cobb TPO Project refers low income survivors of domestic violence, stalking and elder abuse to pro bono attorneys for representation at their TPO hearings in Cobb Superior Court. [Read more.](#)

Terms: The starting salary range for this full-time position is \$30,000-\$35,000 depending on experience. The program provides generous fringe benefits, including paid holidays, vacation, sick, and paid parental leave; health, life, and long and short-term disability insurance; partial payment for dependent health insurance; a salary reduction option for a flexible spending account; educational loan reimbursement up to \$600 per month (after a \$65 deductible and set off of other loan reimbursement amounts); and voluntary tax-sheltered annuity with 3% match.
