



HRMAM Life Member Award

Description:

Life Membership with HRMAM is a prestigious honorary designation recognizing CHRP members who are no longer, or will no longer be, an active Human Resource practitioner. This award is in recognition of significant contributions made to HRMAM or to the Human Resource profession generally.

Important:

Any supplementary/supporting materials may be submitted to Ron Gauthier in addition to this application at rgauthier@hrmam.org. Applications may be submitted any time. Be as specific as possible when answering all questions.

Eligibility Criteria:

HRMAM's Board of Directors may, by Special Resolution, admit as a Life Member, anyone who:

- Is currently a member in good standing
- Is no longer or will no longer be an active Human Resource practitioner
- Has been an active member of the Association for a period of not less than 20 years
- Has a minimum of two (2) and a maximum of five (5) nominators/references, and
- Has made significant contributions to the Association or to the Human Resource profession

A Life Member shall carry the same rights and privileges as a Regular Member, including the right to vote at meetings of members and to hold elected office. A Life Member is exempt from payment of membership dues.

Selection Process:

- HRMAM's Awards Committee will review all applications
- The Awards Committee will make a recommendation to HRMAM's Board of Directors for approval
- Once approved by HRMAM's Board, successful candidates and nominators are notified in writing and the award will be presented at the next HR Excellence Awards
