**\*\*Those renewing must complete 12 EMDRIA Credits in EMDR for every two year renewal period. In order to meet this renewal requirement, your approved 12 EMDRIA Credits must not have been previously used for EMDRIA renewal and/or application purposes. Additionally, the workshop that was attended for EMDRIA Credits should fall between the initial date Certification status was granted or last renewed and the current renew by date.\*\***
