To feed and quench our own, and the world, better.

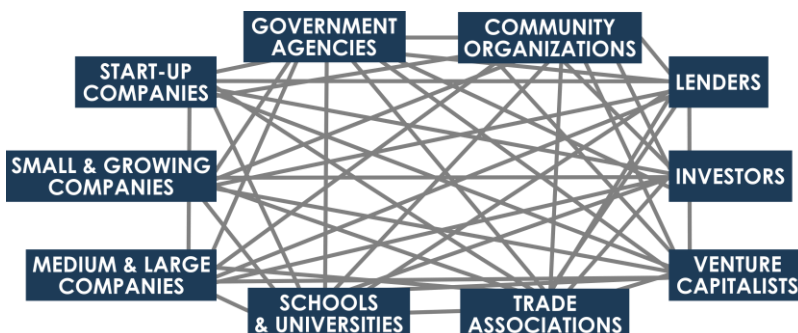

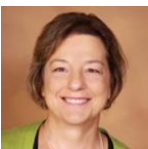
