LETTER OF AGREEMENT

Dear Contributor:

You will defend, indemnify and hold harmless The Family Firm Institute Inc., its employees, agents and representatives against all claims, suits, losses, or damages, including but not limited to, reasonable attorneys' fees and court costs that may be incurred as a result of any libelous or unlawful matter contained in the Material or infringement of any copyright or of any personal or property right or any other breach of this Letter of Agreement.
4. You hereby grant FFI a non-exclusive license to the Material, including the right to make changes in the Material (including any changes to the title) for clarity, brevity, and conformity to style. You will be contacted about your material before it is finalized only if substantive changes, as determined by us, in our sole discretion, are made in the editing process. You will not receive proofs of your Material. The editor will be responsible for all proofreading of the Material. Only typographical errors will be corrected. As part of the non-exclusive license granted hereby you give FFI the right to permit others to use the Material as it sees fit.
5. The Material will be published and sold by FFI, in its own name or any other name selected by FFI in its sole discretion, throughout the world. Nonetheless, you retain all rights in the Material subsequent to publication by FFI, subject to the non-exclusive license granted hereby.
6. If, for any reason, the Material is not published in whole, it will be returned to you with the understanding that you are free to use it for any purpose you desire.
7. You will keep FFI informed of any change in your address.
