

# National Alliance Scholarships for IAIP Members

## *CIC, CRM, CISR, and CSRM Scholarships Exclusively for IAIP Members*

The National Alliance for Insurance Education & Research will award 26 professional continuing education scholarships at the International Association of Insurance Professionals (IAIP) Annual Convention in Albuquerque, NM on June 15-17, 2017, to deserving IAIP members. To Apply for a scholarship, please complete the form on the back. Applications must be received by May 1, 2017.

### **CIC (Certified Insurance Counselor) Scholarships** - Five CIC Scholarships will be awarded.

---

You must be a IAIP member in good standing and have never attended a CIC institute. The exam is required. In addition, you must be a licensed agent, broker, or solicitor; or have at least two years of full-time experience as a practitioner in insurance or risk management; or have served for a least two years as a full-time insurance faculty member at an accredited college or university.

### **CIC Update Scholarship** - *One CIC Update Scholarship will be awarded.*

---

You must be a CIC and a IAIP member in good standing. This scholarship applies to any CIC institutes, James K. Ruble Seminar,\* Dynamics of Selling program,\* or Certified Risk Manager (CRM) course.

\*You must be a dues-paid member of the Society of CIC or Certified Risk Managers International to attend a Ruble seminar, and to receive update credit from a James K. Ruble Seminar or Dynamics of Selling program.

### **CRM (Certified Risk Managers) Scholarships** - *Three CRM Scholarships will be awarded.*

---

You must be a IAIP member in good standing and have never attended a CRM course. The exam is required. With the "CRM for CIC" option, a student may take one CRM course in place of one CIC institute.

### **CISR (Certified Insurance Service Counselor) Scholarships** - *Five CISR Scholarships will be awarded.*

---

You must be a IAIP member in good standing and have never attended a CISR course. The exam is required. Any employee of an agency, insurance company, or insurance-related business, including customer service representatives, insurance agents, and agency managers, is eligible to attend.

### **CISR Online Scholarships** - *Five CISR Online Scholarships will be awarded.*

---

You must be a IAIP member in good standing. Successful completion of the exam is required for state CE credit and CISR Annual update credit. Any employee of an agency, insurance company, or insurance-related business, including customer service representatives, insurance agents, and agency managers, is eligible to attend.

### **CISR Update Scholarships** - *Two CISR Update Scholarships will be awarded.*

---

You must be a CISR and a IAIP member in good standing. This scholarship applies to any CISR course, CSRM course, William T. Hold (WTH) Seminar, or Dynamics of Service course.

### **CSRM (Certified School Risk Managers) Scholarships** - *Five CSRM Scholarships will be awarded.*

---

You must be a IAIP member in good standing and have never attended a CSRM course. The exam is required. Any employee of an agency, insurance company, insurance-related business, or any individual involved in school risk management is eligible to attend. With the "CSRM for CISR" option, a student may take one CSRM course in place of one CISR course.

Each scholarship covers the registration fee only for ONE institute or course, and must be used by December 31, 2018.
