

# KCSDV LEGAL ASSISTANCE FOR VICTIMS PRO BONO ATTORNEY NETWORK APPLICATION



The Kansas Coalition Against Sexual and Domestic Violence’s (KCSDV) Legal Assistance for Victims (LAV) Project is a grant-based pro bono referral program for victims of sexual and domestic violence. No cases are referred without specific approval from the attorney. All potential clients have been screened by advocates for victimization and by the LAV Attorney for appropriateness and income. Pro bono network attorneys are not expected to take on more than one case per year. Network attorneys also have access to KCSDV attorneys for case assistance and drafting, an attorney-only section of the KCSDV website, and free CLE hours. Network attorneys must attend one KCSDV CLE session per year.
