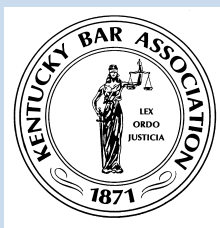

## Driving Directions

From I-75 S/I-64 E, take the Newtown Pike Exit 115 toward Airport/Lexington. Merge onto Newtown Pike. Drive approximately 3 miles. Turn left onto W. Main St. At Triangle Park, stay right to continue on W. Main. Turn left onto Limestone. Turn right onto Barr Street.

From I-75 N/I-64 W, take the US 127/US 68 exit 113 toward Paris/Lexington. Turn right onto N. Broadway/US 27 S. Drive approximately 3 miles. Turn left onto W. Short St. Turn left onto N. Limestone. Take the next right onto Barr St.

Parking is available for a fee in the garage on Barr Street located beside the District Courthouse.

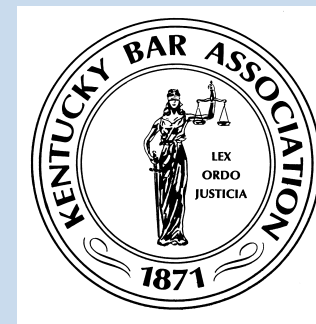
