TUITION

Tuition for the Leadership Lansing program (Oct. 2017-May 2018) is \$2,200 per participant. Applications are due by August 16. Tuition is payable to the Lansing Regional Chamber of Commerce and is deductible under the Internal Revenue Service Code as a business expense. Tuition payments are due by September 1. Companies with multiple applicants will receive a tuition discount of \$200 per applicant.

ACKNOWLEDGMENT
