President's Report - Brian Devine (MA)

At their June 2012 meeting in Baltimore, MD, the Association voted to change the name from the National Independent Educator Standards Boards Association to National Professional Educator Standards Board Association. Work continued on advocacy through vision and mission. Officers elected included Janet Welk (ND) chair, Jennifer Wallace (WA) as vice-chair, and Lynn Hammond (HI) as member at large. A conference call was planned for fall semester.

New directors welcomed include Duane Magee, Iowa; Robert Brown, Kentucky; and Renee Launey-Rodolf, Oklahoma.

On January 25, 2013, the Association held a conference call. State updates included professional educator boards in charge of Race to the Top initiatives, Boards developing and implementing teacher/leader effectiveness measures; researching edTPA use and adoption; dealing with reciprocity and mobility of educators across state lines, researching and contracting for online licensure systems, and working on tiered licensure with focus on pre-service and induction and use of edTPA as part of pre-service exit. All Boards reported working with legislative sessions. Reorganizations of Boards have taken place in lowa, Vermont, and Oklahoma.

The Association would like to have additional time during the NASDTEC Summer Conference to continue their work of advocacy for independent and professional boards.

AACTE edTPA

The American Association of Colleges for Teacher Education (AACTE) has asked NASDTEC to serve on its Teacher Performance Assessment (TPA) advisory board. The purpose of the advisory board is to explore the use of Teacher Performance Assessments as a valid measure of effective teaching by new teachers. As most of you are aware there are a growing number of states using the edTPA and AACTE has invested in the development and implementation of this assessment.

New Project: CEEDAR

NASDTEC will join AACTE, NCATE, CCSSO, NASBE, CEC, and NASDSE as members of the advisory board of a new project located at the University of Florida.

The official title is "Collaboration for Effective Educator Development, Accountability, and Reform," (CEEDAR). The project is funded by the Office of Special Education Programs, of the U. S. Department of Ed. Over the next five years, this work will involve providing intensive technical assistance in 20 states as they revise standards for teachers and leaders, reform teacher and leader preparation, and develop data systems that provide information on K-12 student performance for use in evaluating preparation programs. The work will focus on preparing general education teachers, special education teachers, and school principals to work effectively with students with disabilities.

Military Spouse Licensure and Certification Portability

NASDTEC's Executive Director, Phillip Rogers, has been asked to serve as an observer of a study committee that has been convened by the Uniform Law Commission. The study committee is charged with the investigation of the need for and feasibility of drafting and enacting uniform state legislation on the portability and recognition of professional and occupational licenses of military spouses. This project has grown out of a 2012 report from the PEW Center for the States, a 2012 report from the U.S. Treasury and Defense Departments, and a recent resolution of the American Bar Association House of Delegates.

Data Quality Campaign (DQC)

NASDTEC has been asked to represent jurisdictions on the advisory board for the Data Quality Campaign's project that focuses on data literacy for educators. As you may know, over the last several years, the DQC has been very active in helping states design effective longitudinal data systems. They are now shifting their focus from the systems to the users. When it comes to data systems and uses of data, no other voice has as much clout with legislators (national and state) than the DQC.

NASDTEC Executive Director, Phillip Rogers, recently joined representatives from AFT, CAEP, NBPTS, AIR, AASA, Gates Foundation, Bush Foundation, WestEd, and CCSSO at the first meeting of the advisory group. The focus of the group is to develop a framework definition for data literacy. The importance of this group's work is that this definition will more than likely be widely adopted by legislators and other policy makers.

NASDTEC Online Community (OC)

The NASDTEC OC continues to grow. The number of individuals who have registered to participate has increased to 419. This is up 193 from the original 226 that were uploaded when the site went live in August. This increase reflects a 85% increase in OC members over the last 6 months.

Groups have been established for all NASDTEC interest groups, point of contacts (POC) and a full membership roster for all jurisdictional and associate members.

During the month of February 587 members logged on to the OC. This is an increase of 254 additional log ins since December's 333.

Early Childhood Personnel Center

NASDTEC joins NAEYC, CCSSO, CEC, NASDSE, and seven other national early childhood and education organizations as members of the Project Advisory Board of the Early Childhood Personnel Center.

This project is located at the University of Connecticut and funded by the Office of Special Education at the U.S. Department of Education. Utilizing a regional approach, this project proposes to realize the following goals:

- (1) serve as a national resource on personnel standards, competencies, and recommended practices for personnel providing services to infants, toddlers, and preschool children with disabilities and their families;
- (2) assist States in aligning their personnel standards to national professional organization standards for all personnel providing services to infants, toddlers, and preschool children with disabilities and their families, aligning or integrating those standards with standards for early childhood personnel of all children, and linking those standards to State competencies and certification or licensure requirements;
- (3) assist State agencies and IHEs in developing partnerships with each other to support alignment between preservice and in-service training for all personnel providing services to infants, toddlers and preschool children with disabilities and their families; and
- (4) assist States in developing integrated early childhood professional development systems to ensure that IDEA Part C and Part B preschool programs and personnel in each State are included within the State's professional development initiatives and that all early childhood personnel have the competencies to serve infants effectively, toddlers, and preschool children with disabilities and their families.

Data Literacy Study

WestEd is conducting a study of what schools of education are doing to build teachers' capacity to use data. The study is funded by the Michael and Susan Dell Foundation to examine the courses that are being offered in schools of education that are either stand-alone data courses or courses in which data skills are integrated. The survey is part of a larger study in which West-Ed: (a) is examining syllabi to better understand what exactly is being included in the curricula, (b) conducting case studies for in depth examinations of exemplar programs, and (c) analyzing state licensure and certification documents to identify any requirements that pertain to data literacy.

The survey will be sent out to a sample of schools of education over the next few weeks. It may require different staff within the institution to contribute to its completion. The objective is to maximize the response rate so the results can determine the extensiveness or lack of courses that currently exist that can help address the growing emphasis by policymakers for educators to be able to use data effectively in their practice. The study is being led by Drs. Ellen Mandinach (emandin@wested.org) and Edith Gummer (egummer@wested.org).
