## Membership News from NCRPA

**REVISED!** Individual Professional membership will be \$65/person beginning July 1.

**Citizen Board Members.** For groups without an agency membership, citizen board members can join at \$10/person.

**NEW! College/University package.** For \$400, this new package would include all faculty, staff and students at colleges and universities that have a parks and recreation (or related) curriculum. They will receive discounted exhibitor space at our Annual Conference and promotion via the NCRPA website.

Students that attend a college/university without this membership will be offered a \$10 NCRPA student membership.



**REVISED! Commercial Members package:** available to vendors that provide products and services to the profession. One member will be \$300 or for \$550, all members of a sales team can be members.
