



NSBA 2018 DUES WAIVER APPLICATION

What Are the Qualifications & Application Procedures?

Any member of NSBA suffering a serious financial hardship due to: unemployment, costly medical issues, bankruptcy or other serious financial issues can apply for partial or full waiver of their voluntary dues. The Dues Assistance application requires applicants to certify that payment of dues would pose a serious financial hardship for them and submit a letter explaining the reason for the request based on financial hardship. The Executive Director reviews each request. In addition to the application, the NSBA may request additional or supporting information. ALL APPLICATIONS ARE CONFIDENTIAL and the information will not be shared outside the decision making process.

How Long May One Receive Voluntary Dues Assistance?

Assistance is granted for a one-year period only. Each year in November, the member will receive a dues statement at the full NSBA dues rate. If there is still a financial hardship that necessitates dues assistance, members need to re-apply through the same procedures. No more than 3 waivers, in a 5 year period, will be considered unless otherwise waived by the Executive Council. Waivers for consecutive years will be scrutinized more closely.

Benefits & Section Dues Affected?

Reduction or a waiver in dues will not affect membership benefits, as applicants are entitled to the same full benefits as any other dues paying member. Section dues, however, are not eligible for reduction or waiver, and must be paid in full.

Required Certification

How Much of NSBA Dues Will Be Reduced?

After determining their regular NSBA dues rate (based on years since bar admission in any state), applicants may request a partial (50%) or full (100%) waiver of their voluntary dues.
