Bail Enforcement Certification Courses

PBUS is offering bail enforcement certification courses; courses 3 and 4 will be taught on Tuesday, February 13 at the winter conference. Attendance verification required. **Each course fee is \$50.00.**

Certified Bail Agent Testing Center

CBA classes are offered online at www.pbush.com. Individuals who have paid for a class syllabus online must take the class test at the Testing Center held at each conference venue. A student verification form is required to be signed by the Testing Center instructor for passage and class credit. A MCBA class orientation session will be held at the conference venue. Individuals seeking a MCBA certification **must attend** the orientation session, pay a \$250 application fee and complete; application must be approved before designation is awarded. ___ check if attending the CBA Testing Center or MCBA orientation session. Only full conference registrants can attend the Testing Center.

Continuing Education

Continuing education classes can be taken at either the winter conference or mid-year meeting; **only participants registered for the full conference are eligible to attend any continuing education classes; CE credit good for the all-day general session or Council of Presidents' meeting. Signed form must be completed.**
