CBA Testing Center

CBA classes are offered online at www.pbud.com with the test taken at the Testing Center. A student verification form is required to be signed by the Testing Center instructor for passage and class credit.

A **MCBA orientation session** will be held in conjunction with the Testing Center; individuals seeking a MCBA certification **must attend** the orientation session to receive an application. Application fee is \$250 and must be reviewed before designation is awarded.

Continuing education options are available **only to participants registered for the full conference** and cost \$100 per credit. The Monday seminar or COP meeting is eligible for CE credit at the winter conference; a PBUS board member must sign a student verification form for credit.

Individuals who have taken/passed all six certified bail agent classes may purchase of **CBA graduation plaque** for \$100 to be awarded at the next conference (payment must be received by January 6, 2017).
