Poster Sessions

The Concept: During the first two days of the meet ing there will be poster sessions to encourage a grea deal of the interpersonal contacts most of us find so useful in the SPR meetings. These are called poste sessions because they consist of mounting a simple presentation of the basic study so that the purpose methods, and results can be visually scanned by persons at their own rate. The persons involved with the study stand in the area of their poster, and what usually evolves is a series of small group discussions amplifying what is written or pictured on the poster.

Your Picture: Please do not be modest. Bring a large photo of yourself and add it to your poster. If you should be somewhere else when someone scans your material, they can then find you later in the conference to talk over your study and research topics of mutual interest.

Suggestions: Use an outline form, large letters, bar graphs, diagrams of design, and simplified displays of data. Stick to the central issues, not details that can emerge in discussions. If you have questions, need selected specialized references, want collaboration, by all means say so on the poster.

Materials: We do not yet know enough about the facilities at Asilomar. We presume there will be walls or poster boards ample to our needs. An area will be designated, probably with a no host bar in proximity, or coffee and other refreshments to encourage conversation during the daytime poster sessions. We will have plenty of masking tape. Your poster should be prepared in advance, and could be on heavy white 8x11 inch paper, which can then be taped up as separate or connected panels. Cardboard (as in dividers or folders) will be more wind resistant and weather permitting (it usually is wonderful there) these sessions may be out of doors.
