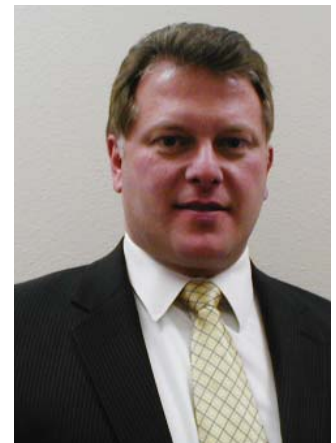

## AIA Committees

AIA Las Vegas provides opportunities for members to contribute, actively participate and share ideas in a variety of ways by working as a member of an AIA Committee.

The **COTE** (Committee on the Environment) acts as the sustainability guide for AIA Las Vegas and helps to plan programs and events that educate and encourage sustainable design.

Event committees contribute to the planning and execution of the annual Golf Tournament, Design and Service Awards, Art, Architecture and Design month, the Learn About/Turn About Product Show.

The **Emerging Professionals** Committee provides young architects, interns, associates and students with opportunities to learn more about practice by providing project tours and meetings with established firms and architects.

## Continuing Education

The Nevada State Board of Architecture, Interior Design and Residential Design requires architects to achieve **8 Continuing Education (CE) Health Safety Welfare (HSW) credits**. Two of the credits must be related to relevant building codes, each year. AIA Las Vegas works in partnership with our Allied members, vendors and manufacturers and the Nevada State Board of Architecture, Interior Design and Residential Design in order to provide

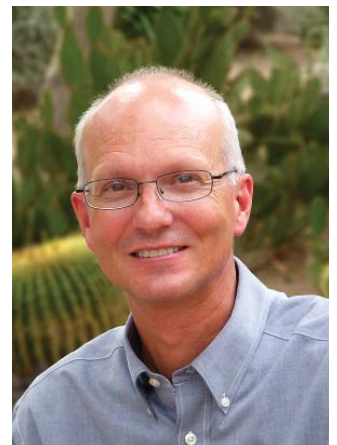
opportunities to achieve the required credits each year.

AIA Architect Members are also required to achieve 18 AIA CE credits in order to maintain membership in the Institute. We work diligently with you, our Allied Members, to provide ample opportunities to present CE courses. Through meetings, lectures, seminars, charettes, workshops and other courses, Architect Members acquire the necessary CE credits for licensure renewal in Nevada and in most other states. Additionally each year, **AIA Las Vegas** joins with the Nevada State Board of Architecture, Interior Design and Residential Design (NSBAIDRD) to provide two full-day seminars, one held in Las Vegas and the other in Reno, through which AIA members can achieve the necessary codes related credits to meet state requirements for license renewal.
