

ABA Member Center Online Dues Payment

Step 1: Go to <http://ameriburn.site-ym.com> and login to the ABA Member Center.

Step 2: Click on the **Membership Info** link in the left hand column under My Profile.

Step 3: To renew, click on the link **“Securely renew your membership now”** as shown below:
