IMPORTANT REGISTRATION & CONFERENCE INFORMATION

Registration Deadlines: To qualify for the early-bird registration fee, a complete registration form and payment must be postmarked or received on or before **August 31, 2017**.

Member Registration Fee: If you are not already a CANO/ACIO member and qualify for membership, you are welcome to join CANO/ACIO for 2017 to take advantage of the reduced member fee for the conference. However, please note that all CANO/ACIO memberships run from January 1 to December 31. Therefore, memberships purchased at the time of conference registration will expire December 31, 2017. To ensure that you receive maximum benefit from your CANO/ACIO membership, we encourage you to join/renew your membership as early as possible in the calendar year. Membership forms can be downloaded from the CANO/ACIO website at www.cano-acio.ca.

Registration Limits: Registration for the 2017 CANO/ACIO Annual Conference is **limited to 700** participants and paid registrations will be accepted on a first-come-first-served basis. Receipts will be emailed to confirm your registration. Due to the limited registrations available, all delegates will require written confirmation of their registration acceptance. We encourage you to **register early** and to complete the registration form fully and properly in order for your registration to be processed.

On-Site Registrations: Please note that, if available, on-site full conference fees may be higher than the full rate. On-site registration rates, if available, will be posted on the website.

Cancellation Policy: For registration fees to be refunded, a written notice of cancellation must be received at the CANO/ACIO Management Office by mail, fax or e-mail **no later than August 31, 2017**. The amount of registration fees remitted, minus a **\$75 administrative charge**, will be refunded after the conference. **Registration fees will not be refunded for any reason after August 31, 2017**. Substitutions are accepted. Please send written notice of substitutions by October 6, 2017.

Conference Workshops: Please note that there are no separate fees for workshops held during the conference (i.e. 7:00am on October 27 to 4:00pm on October 30). Your registration includes access to all CANO/ACIO sessions held during the conference, excluding the social event.

Conference Meals: Included in your registration fee are the Sunday evening Welcome Reception and coffee breaks. Other conference meals are, as usual, not included in the conference fees. However, you may receive invitations in the mail concerning events being held in conjunction with the conference, such as educational breakfasts or luncheons hosted by sponsoring companies. (If you would prefer not to receive these mailings, please indicate this in the space provided on page 1 of the conference registration form). CANO/ACIO is not responsible for registration for these events, nor is there any guarantee that all delegates will be accommodated at these sponsored events.

Social Event: On the evening of Sunday October 29, conference delegates are invited to participate in a social event. Tickets for this event are **\$85** and include a dinner. The tickets for the social event are available on a first-come-first-served basis.
