



## New Associate Hiring Fair – Employer Registration

In an effort to connect current 3L students and recent graduates\* with employers in **Lancaster, Sarpy and Douglas counties** seeking to hire, the Nebraska State Bar Association is conducting its first ever New Associate Hiring Fair during the Annual Meeting. ### New Associate Hiring Fair

**Location:** Embassy Suites La Vista (12520 Westport Pkwy, La Vista, NE 68128).

**Date:** Friday, October 13th (**REGISTRATION DEADLINE: Wednesday, September 27, 2017**)

**Time:** 1:00 P.M. - 5:00 P.M.

**EMPLOYER COST:** \$ 50 (Covers interview space, administrative costs, and refreshments)

**Interview Format:** Each employer will be provided an interview table and a schedule of 15-20 minute screening interviews with applicants seeking FT work in Sarpy, Douglas, or Lancaster counties. We estimate that each attorney will have the opportunity to interview up to 12 attorneys/students. Attorneys, students, and representatives from law firms will have an additional opportunity to meet and converse at a reception following the formal interviewing session. Employers can choose either “Pre-Select/Lottery Hybrid” or “100% Lottery.”

**Pre-Select/Lottery Hybrid:** Ten days prior to the fair, you will be provided PDF booklets of all applicants’ cover letters and resumes for review. Employers may choose 1/2 of their interview slots and the other 1/2 will be filled through lottery.

**Lottery:** Interview slots will be filled 100% through lottery assignment. Employers need only sign up and show up. Administrators will take into consideration practice area needs and applicant location preferences to the extent possible.
