

# KEY FACTS ON FLORIDA FOUNDATIONS

June 2008

## Selected Grantmaker Data, 2006

In 2006, 3,874 independent, corporate, community, and operating foundations headquartered in Florida held assets of more than \$19.2 billion and gave away nearly \$1.2 billion. Nonetheless, the vast majority of Florida foundations are small. Overall, 62 percent of Florida foundations held less than \$1 million in assets, and just over half gave less than \$50,000.

Nearly half of all Florida foundations (1,923) have been established since 1995. In fact, three of the state's largest grantmakers in terms of giving and assets were established within the last decade: Wallace H. Coulter Foundation (2000); Flight Attendant Medical Research Institute, Inc. (2000); and Turner Global Foundation, Inc. (2004).

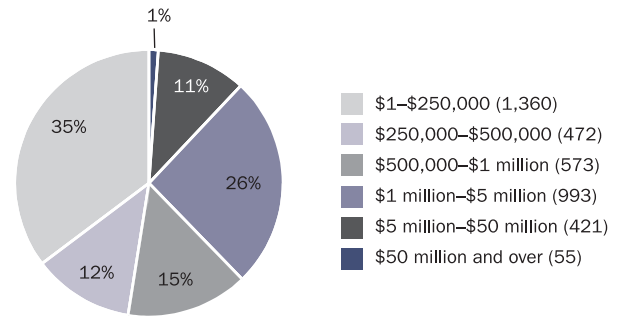
Independent foundations dominated the top 10 givers, which gave a total of \$322 million, or 27 percent of all Florida foundation giving, in 2006. The 10 largest foundations held \$5.9 billion in assets, which was just under one-third of all foundation assets.

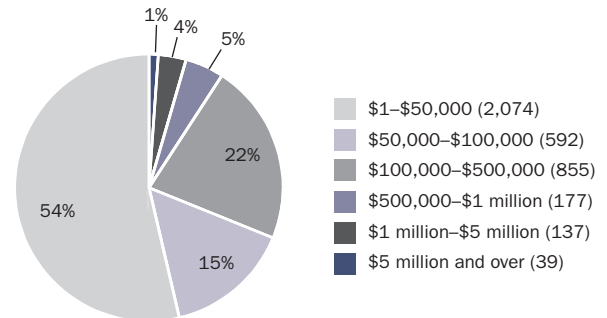
## Florida Foundations by Asset Range, 2006

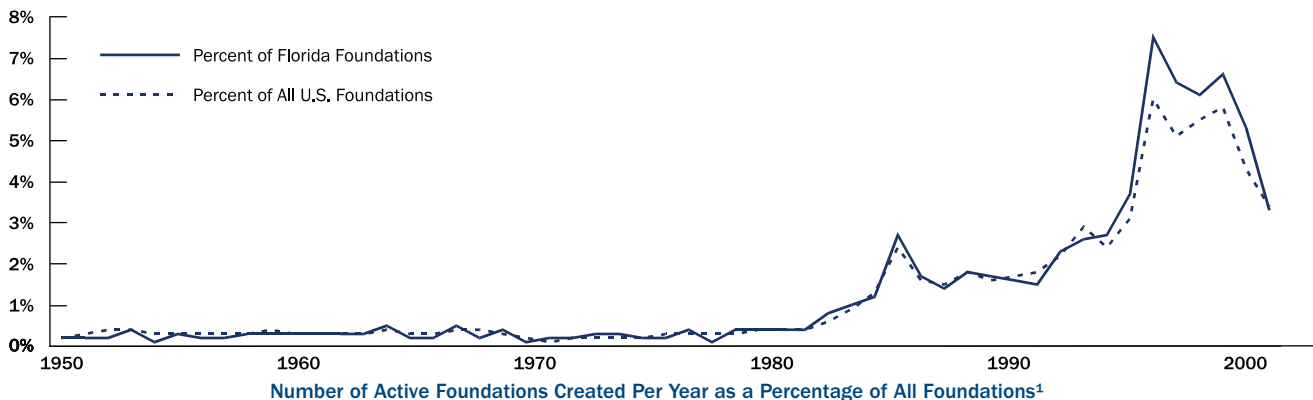
## Florida Foundations by Total Giving Range, 2006

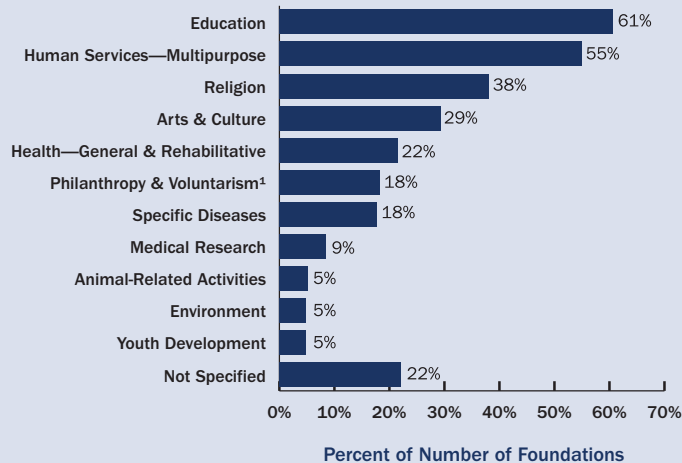

## Selected Giving Interest, 2006

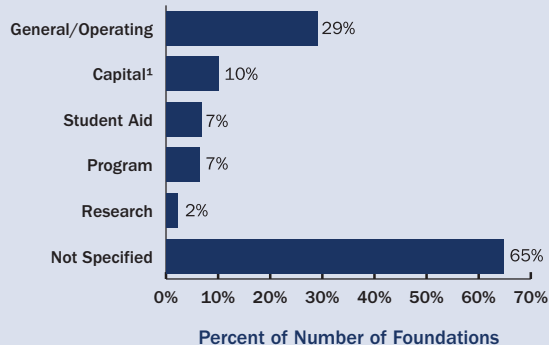
### Major Fields of Interest for Florida Foundations, 2006

The Foundation Center adds “fields of interest” and “types of support” codes to a foundation's record, according to its responses to the Center’s annual survey of larger grantmakers and the approximate distribution of the foundation’s grants. Although these statistics do not predict actual giving patterns, they do indicate the general interests of the state’s foundation community.
