

REGISTRATION AND RENEWAL OF MEMBERSHIP
OF THE PHARMACEUTICAL SOCIETY OF GHANA (PSGH) – 2017

FOR EXISTING MEMBERS AND FELLOWS ONLY

The Pharmaceutical Society of Ghana would like to remind all its members that, per the constitution of the PSGH, each year with effect from 1st January, ALL MEMBERS of the Pharmaceutical Society of Ghana MUST RENEW their membership by providing their UPDATED PROFILE INFORMATION and pay the prescribed MEMBERSHIP SUBSCRIPTION FEES for the RETENTION OF MEMBERSHIP.

For this year 2017, the procedure for Renewal of Membership and payment of the membership subscription for the retention of membership shall be as follows:

1. Visit the website of the PSGH (www.psgh.org), click on and download the "**Existing Member/Fellow Registration Renewal Form**", Fill the required fields.
Also click on the link "**Existing Member/Fellow Online Renewal Profile Update**" and **sign-in to update your profile**
2. Pay the prescribed membership subscription fees (detailed below) at ANY BRANCH of either ECOBANK or ADB BANK.
Note that at the bank, **you only have to inform the Teller that you are paying dues for the Pharmaceutical Society of Ghana (PSGH)**. You may be asked to fill a Fees Collection form. **You do not have to provide any account number**. Rather you need to **indicate your Membership Number, Name, Regional Branch and Type of Dues** being paid (Detailed below).
3. Proceed to the Regional Offices of the Pharmacy Council of the respective region with your copy of the pay-in slip and the filled registration form, to complete the Registration and Renewal Process.
