Payroll Deduction

• Send a copy of your membership form to your school district business office and submit the original to TEPSA.

• Allow up to eight weeks for your payroll office to begin sending payment to TEPSA.

• When deductions begin, ensure you are deducting the proper amount in order for your membership to be paid in full by **May 30, 2018**.

• TEC § 22.001 requires school districts to provide payroll deduction for professional organization dues to employees who request it.

Pending passage of HB510, payroll deduction may be eliminated for educators as of September 1, 2017. If HB510 passes, we will contact you regarding available payment options.
