For those not actively involved in the field of code enforcement and/or regulation. Enjoys bi-monthly publication of the AACE newsletter and conference registration discounts.

Governmental Membership

This membership has several tiers based upon population. All have an unlimited number of non-voting members and a set number of voting members. This membership type is for government entities, not individuals. The government entity then provides names of employees to be added as voting or non-voting members. The fees are paid annually. See the chart below for more information:

| *Population | Voting Members | Fees |
|--------------------|----------------|-------|
| 0 to 25,000 | 2 | \$100 |
| 25,001 to 50,000 | 4 | \$250 |
| 50,001 to 150,000 | 6 | \$400 |
| 150,001 to 300,000 | 10 | \$700 |
| 300,001 and over | 12 | \$850 |

* Data from most current United States census survey shall be used to determine population of a Governmental Member.

The American Association of Code Enforcement was incorporated March 12, 1988 by representatives from five states. We have since grown to an organization with members representing 44 states, the District of Columbia and Canada.

Professional Certification

We offer certification programs in the following areas:
