On Monday, August 21, 2017, the Legislature returns to Sacramento for the last 4 weeks of the first half of the Legislative Session.

Both the Assembly and Senate Appropriations Committees will meet next week to consider hundreds of measures to determine the fiscal impact the bills will have on the State. It is expected most of the bills will be referred to each Committee's respective Suspense File. The Suspense Files will be considered before the September 1, 2017, fiscal committee legislative deadline.
